Agreement for the Establishment of the Asia-Pacific Fishery Commission

2. Cover page and page 2 of document C 95/INF/21 (French version): The title should read "Accord portant création de la Commission Asie-Pacifique des Pêches...".
3. Cover page (French version): - "Amendements à la Convention, approuvés par le Conseil de la FAO à sa cent septième session (novembre 1994)".
4. Page 3, paragraph 11, last line (French version) should read: "...Commission Asie-Pacifique des Pêches".

5. On 21 July 1995, the Government of the Republic of Mozambique deposited an instrument of acceptance of the Constitution.

**III. CONVENTIONS AND AGREEMENTS CONCLUDED OUTSIDE THE FRAMEWORK OF FAO
IN RESPECT OF WHICH THE DIRECTOR-GENERAL EXERCISES DEPOSITARY FUNCTIONS**

**Regional Convention on Fisheries Cooperation
among African States bordering the Atlantic Ocean**

9. On 12 July 1995, the Government of the Republic of Guinea-Bissau deposited an instrument of accession to the Convention, thus enabling the Convention to come into force on **11 August 1995** (thirty (30) days after the deposit of the seventh instrument of ratification, acceptance, approval or accession).

**Agreement for the Establishment of Near East
Plant Protection Organization**

10. On 3 October 1995, the Government of the Hashemite Kingdom of Jordan deposited an instrument of ratification of the Convention.

**Convention for the Establishment of the
Lake Victoria Fisheries Organization**

11. Page iv of document C 95/INF/21 (English version): The Convention was concluded at Kisumu, Kenya on **30 June 1994**.
