## CONFERENCE

### Thirty-fifth (Special) Session

Rome, 18 – 22 November 2008

### Report of the Credentials Committee

1. The Credentials Committee held three meetings on 13, 18 and 20 November 2008 to examine the credentials of Delegations of Members of the Organization to the Thirty-fifth (Special) Session of the Conference. The Committee elected Mrs Daniela Rotondaro (San Marino), as its Chairperson, and Mr Rasmi Mahmoud (Oman), as its Vice-Chairperson.
2. The Committee conducted its review of the credentials received in accordance to Rules III.2 and XXI.4 of the General Rules of the Organization on "Delegations and Credentials".
3. List A and list B, herewith attached, provide the name of Members of which credentials were received in due form by 20 November 2008.
4. The Committee recommends to the Conference that the credentials of the delegations on both lists be accepted and that such delegations be authorized to participate fully in the Conference session.
5. The Committee was informed that one Member had communicated the composition of its delegation without submitting credentials, and that three Members had communicated their inability to attend the Conference. Thirty-three Members had not provided any credentials.
