Reliable and up-to-date information on the state of forest resources - not only on area and area change, but also on such variables as growing stock, wood and non-wood products, carbon, protected areas, use of forests for recreation and other services, biological diversity and forests' contribution to national economies - is crucial to support decision-making for policies and programmes in forestry and sustainable development at all levels.

FAO, at the request of its member countries, regularly monitors the world's forests and their management and uses through the Forest Resources Assessment Programme. This country report forms part of the Global Forest Resources Assessment 2010 (FRA 2010).

The reporting framework for FRA 2010 is based on the thematic elements of sustainable forest management acknowledged in intergovernmental forest-related fora and includes variables related to the extent, condition, uses and values of forest resources, as well as the policy, legal and institutional framework related to forests. 1.1 FRA 2010 Categories and definitions

Category	Definition
Forest	Land spanning more than 0.5 hectares with trees higher than 5 meters and a canopy cover of more than 10 percent, or trees able to reach these thresholds <i>in situ</i> . It does not include land that is predominantly under agricultural or urban land use.
Other wooded land	Land not classified as “Forest”, spanning more than 0.5 hectares; with trees higher than 5 meters and a canopy cover of 5-10 percent, or trees able to reach these thresholds <i>in situ</i> ; or with a combined cover of shrubs, bushes and trees above 10 percent. It does not include land that is predominantly under agricultural or urban land use.
Other land	All land that is not classified as “Forest” or “Other wooded land”.
Other land with tree cover (Subordinated to “Other land”)	Land classified as “Other land”, spanning more than 0.5 hectares with a canopy cover of more than 10 percent of trees able to reach a height of 5 meters at maturity.
Inland water bodies	Inland water bodies generally include major rivers, lakes and water reservoirs.

2.1 FRA 2010 Categories and definitions

Term	Definition
Primary designated function	The primary function or management objective assigned to a management unit either by legal prescription, documented decision of the landowner/manager, or evidence provided by documented studies of forest management practices and customary use.
Protected areas	Areas especially dedicated to the protection and maintenance of biological diversity, and of natural and associated cultural resources, and managed through legal or other effective means.
Categories of primary designated functions	
Production	Forest area designated primarily for production of wood, fibre, bio-energy and/or non-wood forest products.
Protection of soil and water	Forest area designated primarily for protection of soil and water.
Conservation of biodiversity	Forest area designated primarily for conservation of biological diversity. Includes but is not limited to areas designated for biodiversity conservation within the protected areas.
Social services	Forest area designated primarily for social services.
Multiple use	Forest area designated primarily for more than one purpose and where none of these alone is considered as the predominant designated function.
Other	Forest areas designated primarily for a function other than production, protection, conservation, social services or multiple use.
No / unknown	No or unknown designation.
Special designation and management categories	
Area of permanent forest estate (PFE)	Forest area that is designated to be retained as forest and may not be converted to other land use.
Forest area within protected areas	Forest area within formally established protected areas independently of the purpose for which the protected areas were established.
Forest area under sustainable forest management	To be defined and documented by the country.
Forest area with management plan	Forest area that has a long-term (ten years or more) documented management plan, aiming at defined management goals, which is periodically revised.

3.1 FRA 2010 Categories and definitions

Term / category	Definition
Naturally regenerated forest	Forest predominantly composed of trees established through natural regeneration.
Introduced species	A species, subspecies or lower taxon, occurring <u>outside</u> its natural range (past or present) and dispersal potential (i.e. outside the range it occupies naturally or could occupy without direct or indirect introduction or care by humans).
Characteristics categories	
Primary forest	Naturally regenerated forest of native species, where there are no clearly visible indications of human activities and the ecological processes are not significantly disturbed.
Other naturally regenerated forest	Naturally regenerated forest where there are clearly visible indications of human activities.
Other naturally regenerated forest of introduced species (sub-category)	Other naturally regenerated forest where the trees are predominantly of introduced species.
Planted forest	Forest predominantly composed of trees established through planting and/or deliberate seeding.
Planted forest of introduced species (sub-category)	Planted forest, where the planted/seeded trees are predominantly of introduced species.
Special categories	
Rubber plantations	Forest area with rubber tree plantations.
Mangroves	Area of forest and other wooded land with mangrove vegetation.
Bamboo	Area of forest and other wooded land with predominant bamboo vegetation.
