AUDIENCE WITH HIS HOLINESS POPE BENEDICT XVI

On the occasion of the 37th Session of the Conference, His Holiness Pope Benedict XVI will receive in Audience Delegates to the Conference. The Audience will take place in the "Sala Clementina" on Friday, 1 July 2011 at 11.00 hours. Doors to the hall will be closed at 10.45 hours.

Entrance to the Sala will be effected through the "Portone di Bronzo", on the right-hand side of Piazza San Pietro, upon presentation of a special access card and screening through a metal detector by the Italian Police authorities. A bus service will be provided to and from the Vatican. Buses will leave from FAO (Building A) at 09.30 hours and will return at 12.30 hours approximately.

The cards will be distributed upon request at a desk marked "Papal Audience" in the Belgian Lounge (main entrance to the Plenary Hall), from Monday, 27 June to Thursday, 30 June 2011, from 09.30 to 12.00 hours.
