# Arrangements for the 38<sup>th</sup> Session of the Conference (15-22 June 2013)

### **Executive Summary**

This document contains a tentative Timetable for the 38<sup>th</sup> Session of the Conference and lists the officers of the Conference for which candidates need to be nominated.

  - Seven Members of the Resolutions Committee.

#### Introduction

1. As decided by the 37<sup>th</sup> Session of the Conference (June-July 2011), the 38<sup>th</sup> Session of the Conference will be held in Rome from Saturday, 15 to Saturday, 22 June 2013. The Provisional Agenda for the Session was approved by the 145<sup>th</sup> Session of Council (December 2012). Item 19, "United Nations/FAO World Food Programme", a standing item at sessions of the Conference, was inadvertently omitted from the draft Agenda submitted to Council, and was subsequently added.

2. This document complements the arrangements for the 38<sup>th</sup> Session of the FAO Conference (15-22 June 2013) approved by the Council at its 145<sup>th</sup> Session (December 2012), which are contained in C 2013/12, including the proposal that the theme for the General Debate of the Conference under item 9 "Review of the State of Food and Agriculture" be "Sustainable Food Systems for Food Security and Nutrition".

### **Tentative Timetable**

3. A tentative timetable for the Conference (*Appendix A*) is now submitted for consideration by the Council, and subsequent submission to the Conference for approval.

### **Officers of the Conference**

4. The Council at its 145<sup>th</sup> Session (December 2012) expressed consensus for the nomination of His Excellency Mohammad Asif Rahimi, Minister for Agriculture, Irrigation and Livestock of Afghanistan as Chairperson of the Conference and, furthermore, recommended that the Chairperson of Commission I be from a country from the G77 and China Group, and that the Chairperson of Commission II be from a country not within the G77 and China Group.<sup>1</sup>

5. In keeping with Rule XXIV-5(b) of the general Rules of the Organization, the Council is requested to nominate candidates for the following positions:

- (i) Chairperson of Commission I;
- (ii) Chairperson of Commission II;
- (iii) Three Vice-Chairpersons of the Conference;
- (iv) Seven elected Members of the General Committee;
- (v) Nine members of the Credentials Committee.

6. Furthermore, in keeping with past practice, the Council is also expected to nominate seven members of the Resolutions Committee.

### **Informal Meeting for Non-Governmental Organizations**

7. As at previous sessions of the Conference, it is proposed that observers from Non-Governmental Organizations be invited to attend an informal meeting on Saturday 15 June 2013, so that their advice and suggestions on FAO activities and programmes may be communicated to the Conference.
