

8. NOTAS

- ¹ Se deduce una estimación similar del número de personas que dependen de la pesca en pequeña escala de Safina (1995: 52), que sugiere que unos 200 millones de personas dependen en todo el mundo de la pesca para su subsistencia. Sus cifras no distinguen entre pescadores en pequeña escala y en gran escala, ni entre productores primarios y otros que dependen de la pesca para su subsistencia. Sin embargo, si sus cifras son exactas y se refieren tanto a productores primarios como a otros que dependen de la pesca, y suponiendo que aproximadamente el 95% de las personas que dependen de la pesca lo hacen en pequeña escala, puede deducirse de sus cifras que hay en todo el mundo unos 190 millones de personas que dependen de la pesca en pequeña escala.

- ⁵ Los investigadores deberían actuar con cautela cuando confían en información estadística sobre las comunidades en pequeña escala que han obtenido de fuentes secundarias. Esto se debe a las dificultades que entraña la realización de censos exactos de una población pesquera que frecuentemente se halla dispersa en zonas de difícil acceso, pueden desplazarse en las distintas estaciones de pesca y puede distribuir sus capturas en muchos lugares.
- ⁶ En Ben-Yami y Yerson (1985), aparecen sugerencias útiles sobre cómo los funcionarios de pesca pueden ayudar a los miembros de las comunidades pesqueras en pequeña escala en el establecimiento y funcionamiento de organizaciones eficaces.
- ⁷ Al comienzo, el nombre completo de este programa era *Programa Especial sobre Producción en Apoyo de la Seguridad Alimentaria en los Países de Bajos Ingresos con Déficit de Alimentos (PBIDA)*.

- ⁸ Según el Comité de Pesca de la FAO (FAO 1995b), los PBIDA son aquellos países que tuvieron una balanza comercial negativa en cereales durante los cinco años anteriores y unos ingresos per cápita iguales o inferiores a los utilizados para determinar el derecho a la financiación de la AIF/BIRF (es decir, un PNB per cápita de 1305 dólares EE.UU. en 1992). Según el Cuadro de Expertos de Alto Nivel sobre Pesca, patrocinado por la FAO, los PBIDA son países que tuvieron un intercambio comercial de alimentos negativo en el período 1992-94 e ingresos per cápita iguales o inferiores a los utilizados para determinar el derecho a la financiación de la AIF/BIRF (es decir, un PNB per cápita de 1465 en 1995). Además, el país habrá tenido que designarse asimismo como PBIDA (FAO 1998: 1). De los 78 países clasificados como PBIDA, 43 se hallan en África.
- ⁹ En cuanto a los Pequeños Estados Insulares en Desarrollo (PEID), de los estados miembros de la Alianza de Pequeños Estados Insulares (AOSIS), 11 han sido clasificados como PBIDA y en 6 de ellos el pescado proporciona más del 50% de las proteínas animales en la dieta. Los 11 miembros de la AOSIS que son PBIDA son Cabo Verde, Comoras, Guinea Bissau, Kiribati, Maldivas, Papua Nueva Guinea, Samoa, Sao Tome y Príncipe, Islas de Salomón, Tuvalu, y Vanuatu.
