

粮农组织每两年出版一期《世界森林状况》系列丛书,介绍全球林业部门的总体状况,包括与林业相关的环境、经济和社会等方面的情况。本期第七版考察了可持续森林管理的进展状况。第一部分回顾了各区域的进展状况。每个区域的报告內容均由可持续森林管理的七大主题要素构成,这七大主题要素已被国际论坛确定为可持续森林管理框架,包括:森林资源的规模;生物多样性、森林健康及活力;森林资源的生产功能;森林资源的保护功能;社会经济功能;以及法律、政策和体制框架。这些报告內容建立在可获得的最新信息基础之上,包括《2005年全球森林资源评估》(FRA 2005)提供的比以往更为全面的新数据。第二部分提出了林业部门的若干问题,探讨了对18个林业热点问题的认识现状或新近开展的行动。气候变化、森林景观恢复、森林占有权、入侵性物种、野生动物管理和木质能源是其中的几个方面问题。《2007年世界森林状况》将为决策者、林业工作者、学者以及所有关注当今影响林业部门主要问题的读者提供有益的参考。
