Codex General Standard for Food Additives (GSFA)

Agenda Item 5 (a): Draft and proposed draft food additives provisions of the GSFA (Doc. Ref. CX/FA 10/42/5)

The 41st CCFA, agreed to request the United States of America to prepare a document compiling all provisions which could not be considered at the Session, along with written comments. The documents also includes provisions for selected food additives (*see* ALINORM 09/32/12, paras 83 and 106). Comments on document prepared by the United States of America are compiled in CX/FA 10/42/5 Add.1.

Agenda Item 5 (b): Comments and information on several provisions of GSFA (replies to CL 2009/7-FA Part B, points 6-9) (Doc. Ref. CX/FA 10/42/6)

The 41st CCFA agreed to request comments and information on: (i) application of note 161 "Subject to national legislation of the importing country aimed, in particular, at consistency with Section 3.2 of the Preamble"; (ii) technological justification for the use of certain colours in selected food categories; and (iii) uses and use levels of selected food additives (*see* ALINORM 09/32/12, paras 22, 23, 27, 28, 89, 99 and 103). Document CX/FA 10/42/6 compiles comments and information submitted in response to CL 2009/7-FA Part B, point 6-9.

Agenda Item 5 (c): Comments and information on the reporting basis of the provisions for aluminium containing food additives included in the GSFA (replies to CL 2009/10-FA) (Doc. Ref. CX/FA 10/42/7)

The 41st CCFA agreed to request clarification on the reporting basis (e.g. as aluminium; molecular weight) of all provisions (adopted and in the Step process) for aluminium containing food additives (*see* ALINORM 09/32/12, para. 66). Document CX/FA 10/42/7 compiles comments and information submitted in response to CL 2009/10-FA.

Agenda Item 5 (d): Comments and information on several aspects of the Food Category System of the GSFA (replies to CL 2009/7-FA Part B, points 10-12) (Doc. Ref. CX/FA 10/42/8)

The 41st CCFA agreed comments and information on several aspects of the Food Category System of the GSFA (*see* ALINORM 09/32/12, paras 147, 149, 151 and Appendix X). Document CX/FA 10/42/8 compiles comments and information submitted in response to CL 2009/7-FA Part B, points 10-12.

Agenda Item 5 (e): Discussion Paper on innovative proposals to expedite the work on the GSFA (Doc. Ref. CX/FA 10/42/9)

The 41st CCFA agreed to issue a Circular Letter (CL 2009/7-FA Part C) requesting comments and innovative proposals to expedite its work on the GSFA (*see* ALINORM 09/32/12, para 108). Document CX/FA 10/42/9, prepared by the Codex Secretariat, consolidates the comments submitted. Comments to the document are compiled in CX/FA 10/42/9 Add.1.
