Item 2 – Matters Referred to the Committee by the Codex Alimentarius Commission and Other Codex Committees and Task Forces (CX/FICS 10/18/2): The document was prepared by the Codex Secretariat concerning matters referred by the last Session of the Codex Alimentarius Commission and other Codex Committees and Task Forces.

Item 3 (a) – Activities of FAO and WHO relevant to the work of CCFICS (FICS/18 INF/1): The document contains information on activities of FAO and WHO relevant to the work of the CCFICS. The document is for information and is only available in the original languages submitted by FAO and WHO.

Item 4 – Proposed draft Principles and Guidelines for the Conduct of Foreign On-site Audit and Inspections (N07-2008), at Step 4 (CX/FICS 10/18/3): The 17th CCFICS agreed to return the proposed draft principles and guidelines to Step 2 for redrafting, circulation for comments at Step 3 and further consideration at Step 4 at the 18th CCFICS (ALINORM 09/32/30, para. 37). Item 5 – Proposed draft Principles and Guidelines for National Food Control Systems (N06-2009), at Step 4 (CX/FICS 10/18/4): The 32nd Session of the Codex Alimentarius Commission approved the proposal of the 17th CCFICS to start new work on the development of a Principles and Guidelines for National Food Control Systems (see ALINORM 09/32/REP para. 113 and Appendix VI). Comments at Step 3 on the proposed draft principles and guidelines, prepared by the physical Working Group established by the 17th CCFICS (see ALINORM 09/32/30 para. 71), are compiled in CX/FICS 10/18/4 Add.1.
