#### TECHNICAL CAPACITY DEVELOPMENT OVERVIEW

1. Under their respective mandates, goals and workplans, FAO and WHO are engaged in a range of food safety and quality technical capacity development activities at national, regional and international levels. These capacity development activities directly support the Codex Strategic Plan 2008–2013; in particular, activities 1.7, 2.6 and 5.4.

2. FAO and WHO capacity development activities are generally aimed at:

- upgrading the capacity of developing member countries in food safety, quality control and quality ٠ assurance and supporting their effective participation in the work of Codex;
- enhancing the respective roles of the agriculture and health sectors and trade and industry in ensuring • the safety and quality of the food supply; and
- strengthening cooperation and collaboration between FAO and WHO and partner organizations, in • the field of food safety and quality.

Since the last session of the Codex Alimentarius Commission, FAO and WHO (either jointly or 3. together with partner organizations and donors) have commenced or are continuing to deliver over 185 direct technical assistance projects on food safety and quality to countries in all global regions. More than 80 regional projects and international events addressing food safety issues were also delivered and more than 40 technical capacity development project proposals are under formulation.

4. Detailed lists of capacity development activities at the regional and national levels are provided in Annexes 1-6. Joint FAO/WHO Codex training/capacity-building organized by the Codex Trust Fund in collaboration with Codex partners for the period in question appears in the annual reports and progress reports of the Codex Trust Fund which are submitted to CCEXEC and CAC. A range of supporting materials (e.g. guidelines, manuals and online resources), global information exchange systems, international events and global projects have also been delivered since the last session of the Codex Commission, or are under development by FAO and/or WHO. Details of recent materials and activities are provided in Part I with other related activities being described in Annex 7.

5. Looking ahead, priorities for the coming year, which may be implemented jointly by FAO and WHO, or in association with other partner organizations, include:

- providing policy advice and supporting the establishment of food and feed safety regulatory and institutional frameworks;
- strengthening official food safety systems through the use of the risk analysis framework including risk assessment of food hazards;
- facilitating the input/access of national scientists to international risk assessment and provision of scientific advices.
- enhancing food safety laboratory capabilities, and planning and implementation of food inspection systems;
- integrating preparedness and response capacities to food and feed safety systems, to address food and feed safety emergencies;
- foster countries' epidemiological capacity to conduct national foodborne disease burden studies and strengthen research utilization in policy development and practice;
- targeted training for food safety officials and technical staff (food safety managers, food inspectors, and food analysts) in carrying out their respective duties,
- supporting national Codex programmes (including Codex Contact Points and National Codex Committees) to facilitate effective participation in Codex;
- enhancing food and feed safety management (including implementation of good hygiene practices, and good agricultural practices) by food producers and food processors;
- strengthening regional and international food control information exchange and cooperation activities;
- developing global tools and training materials to assist food and feed safety and quality control activities; and
- providing tailored regional and sub-regional Codex training to further enhance developing country participation in Codex activities at global, regional and national levels.

Capacity development activities at national and regional levels are implemented according to organizationwide strategic planning as well as in response to direct requests from member countries. These activities are developed, managed, delivered and evaluated, either through the respective FAO and WHO regional, or headquarters offices, depending on the nature of the project.

# PART I: RECENT TOOLS AND TRAINING MATERIALS TO SUPPORT CAPACITY DEVELOPMENT

6. FAO and WHO are engaged in the development of a number of manuals, guidelines and training materials to facilitate the capacity development effort. These materials are particularly relevant to policy makers responsible for strengthening food control programmes. Most are developed jointly and some through specific field projects operated either by FAO or WHO. Information on materials recently developed (mainly since the last session of the Commission) and ongoing tools is given below. A description of other relevant capacity development publications and tools is provided in Annex 7.

- FAO began work on a CD-Rom based technical resource package on food hygiene and quality assurance. The target audience for the resource package includes governmental and non-governmental organizations which provide training and other technical support to small and medium-scale businesses on programmes of food hygiene and quality assurance.
- FAO developed a standardized training package to assist countries in implementing relevant Codex . texts related to the food safety assessment of foods derived from recombinant-DNA plants. This training package, entitled "GM food safety assessment: tools for trainers", contains both theory and practical examples of risk assessments of foods derived from modern biotechnology and a guide for training regulators. The pre-publication copy is available and the publication including a CD with training materials available in English, French Spanish is and at www.fao.org/docrep/012/i0110e/i0110e00.htm. - FAO published a "Risk-Based Food Inspection Manual" which introduces a risk-based inspection approach and procedures for primary production operations and food processing establishments. The publication is available in English, French and Spanish at www.fao.org/docrep/010/i0096e/i0096e00.htm. The Russian language version is in print.
- As a complement to this work, "Guidelines for risk-based fish inspection" which provide technical information to support fish inspection systems was published in English, French and Spanish at <a href="http://www.fao.org/docrep/011/i0468e/i0468e00.htm">www.fao.org/docrep/011/i0468e/i0468e00.htm</a>.
- FAO has initiated development of an "Imported Food Control Manual". The manual aims to assist official authorities in the development, review and implementation of national imported food control programmes and will be in line with guidance developed by CCFICS and related FAO and WHO texts on risk based inspection and food control.
- WHO/AFRO developed a Training Manual on Food Safety Risk Analysis. The document is being finalized in English and will be translated into French and Portuguese in due course.
- WHO/AFRO elaborated guidelines on inclusion of food safety, nutrition and food security in Poverty Reduction Strategies and development papers.
- WHO/AFRO included food safety in guidelines for nutrition in HIV/AIDS programmes.
- WHO/AFRO prepared guidelines for strengthening national food control and field tested in Benin, Cote d'Ivoire, the Gambia, Uganda, Seychelles and Ghana.
- WHO/AFRO developed Regional Guidelines on foodborne disease surveillance.
- WHO/AFRO included foodborne disease surveillance in the new Technical Guidelines for Integrated Disease Surveillance and Response in the African Region.
- developing WHO safety emergency • FAO and are food response guidelines to assist member countries to both prepare for and manage such emergencies. In addition, a series of subject specific guidelines on food recalls, food complaint systems, risk communication during food safety emergencies and risk assessment and risk management for urgent food safety events are being developed to provide more detailed guidance on these important aspects of food safety emergency preparedness, alert and response.
- FAO and WHO, in collaboration with the Industry Council for Development (ICD), are developing a toolkit of practical training materials on risk analysis for food safety practitioners.
- FAO has initiated work on developing benchmarks to guide governments on capital costs and running costs of developing and implementing effective official systems of food control. Along with national level assessments of their food control systems, these benchmarks will provide a useful tool to governments in planning investments in food control.

- FAO is developing a publication on "Aid for trade: food safety and quality" as part of series of "Aid for trade" publications. This publication will explain the importance of food quality and safety issues in the food trade and will provide an updated account of what FAO does in this area.
- FAO published a book in English and French: "Linking People, Products and Places; a guide for promoting quality linked to geographical origin and sustainable GIs". The aim of this guide is to provide local stakeholders with a conceptual framework, concrete illustrations and methodologies for the promotion and preservation of specific quality products linked to geographical origin and for implementation of GI schemes. The Spanish version will be available soon.
- FAO is publishing six Asian case studies on specific quality linked to geographical origin and GI schemes, which analyze advantages, constraints and key factors for GI schemes development from the lessons learnt in six countries (Cambodia, China, India, Indonesia, Mongolia and Thailand).
- FAO and WHO published "The Impacts of Private Food Safety Standards on the Food Chain and on Public Standard-Setting Processes". This publication was introduced at the 32<sup>nd</sup> Session of the Commission and is available in English (<u>www.fao.org/docrep/012/i1132e/i1132e00.pdf</u>), French (<u>www.fao.org/docrep/012/i1132f/i1132f/i1132f/00.pdf</u>) and Spanish (<u>www.fao.org/docrep/012/i1132s/i1132s00.pdf</u>).
- FAO and WHO developed a "FAO/WHO Framework for Developing National Food Safety Emergency Response Plans". This document was developed to assist countries in the formulation and implementation of national food safety emergency response plans. The document will be available in English, French and Spanish and will be used for future capacity development activities to implement preparedness for food safety emergencies at both regional and national levels.
- A status report on FAO activities to build capacity for effective participation in Codex "Making the Codex Connection to Food Safety" is in final stages of preparation.
- JEMRA has developed a tool to assess performance of microbiological sampling plans. It is currently under review and will be available later this year. Subsequently, training materials will be developed on design of sampling programmes, which will include increased understanding and use of the tool.
- FAO is developing a publication on "Milk and dairy products in human nutrition" which will include a chapter on quality and safety of milk and dairy products.
- A manual on "Buenas Prácticas de Higiene en la Preparación y Venta de los Alimentos en la Vía Pública en Latinoamérica y el Caribe" has been published. (<u>http://www.rlc.fao.org/es/inocuidad/pdf/higiene.pdf</u>)
- The FAO/RLC developed an e-learning course on "Hygienic Food Handling I". The course provides tools on hygienic food handling practices to ensure food safety and reviews the basic codes of hygiene. (http://www.rlc.fao.org/nucleo/curso\_MHA200904.htm)
- The FAO/RLC e-learning training courses on "Hygienic Food Handling" (Manipulación Higiénica de los Alimentos) Versions II and III are now available. The courses provide tools on hygienic food handling practices to ensure food safety and review the basic Codex codes of hygiene. (http://www.rlc.fao.org/nucleo/curso\_MHA200904.htm)
- The FAO/RLC e-learning training course "Risk Analysis for Food Safety" (Análisis de Riesgos de la Inocuidad de los Alimentos) is now available. The course is based on documents published by FAO and the Codex Alimentarius relating to risk analysis. (<u>http://www.rlc.fao.org/nucleo/cursos/ARIA201004.htm</u>)
- The FAO/RLC "Eat safely" campaign to prevent food-related diseases has been conducted in all the Latin American and Caribbean countries. The campaign provides information in English, Spanish ("Come Sano"), French ("Mange Sain") and Portuguese ("Coma Saudavel") on the good practices for safe and healthy eating, including handling and preparation of food at home. - The FAO/RLC "Eat Safely" programme has been extended to a radio broadcast campaign in local native languages (Quechua, Creole, etc) in the Dominican Republic, El Salvador, Guatemala, Haiti, Panama and Peru.
- The FAO/RLC developed an e-learning course on "Food Safety Control Systems", and it is available at (http://www.rlc.fao.org/nucleo/curso\_SCIA200909.htm).

## PART II: GLOBAL INFORMATION EXCHANGE MECHANISMS

7. The International Portal on Food Safety, Animal and Plant Health (<u>www.ipfsaph.org</u>) has undergone significant technical work since June 2009 with the goal of making it more intuitive to use, both for retrieving information and for publishing official national records. As of April 2010, the portal indexed approximately 50,000 records collected from over 50 different official data sources. The focus of the Portal is being streamlined so that its two basic functions are more apparent on the home page: first, the Portal is a free information database for general public worldwide; and second, it is a simple-to-use publishing platform for registered users with an account, by means of which official food safety, animal health and plant health information may be shared. The core searching function has been significantly strengthened to enable chronological and advanced searches, and various other functions have been added and/or improved.

8. In addition, the data set for food safety assessment of r-DNA plants authorized in accordance with the Codex Guideline for the Conduct of Food Safety Assessments of Foods Derived from Recombinant-DNA Plants has undergone technical and user-oriented improvements to make it easier both to add official safety assessments from national government or other official organization sources, and to search the information. This data set operates in cooperation with the OECD BioTrack database, an interoperable central database containing food safety assessments relating to foods derived from r-DNA plants. The data set gathers food safety assessment records for approved transformation events from various official online sources including OECD BioTrack, the Biosafety Clearing House and the EC Register of Genetically Modified Food and Feed, among others.<sup>1</sup> As the technical work described above nears completion, all Codex members will be invited to upload their relevant records, including LLP-rDNA data, into IPFSAPH. 9. INFOSAN is now a joint FAO/WHO initiative, with the secretariat in WHO. The network currently includes the participation of 177 member states. The aim of the network is to promote the rapid exchange of information during food safety related events, share information on important food safety related issues of global interest, promote partnership and collaboration between countries, and help countries strengthen their capacity to manage food safety emergencies. Some of the key areas for development in 2010 include strengthening the collaboration of Member States to encourage communication and technical exchange of risk assessments and best practices, and enhancing linkages with other relevant organizations and networks. INFOSAN is also an important partner with FAO's EMPRES Food Safety programme.

10. FAO, in collaboration with several partners, has launched a web-based Gateway to Animal Feeding (<u>www.fao.org/ag/animalfeeding.html</u>) which gives particular relevance to feed safety issues and provides a single access point to a wide range of information (legislation, codes of practices, scientific and technical documents, training material, a directory of experts and organizations, etc.) and a platform to engage in thematic fora. The Gateway strengthens synergies and encourages partnership amongst government institutions, the private sector, non-governmental organizations, scientists, etc. to facilitate the funding, execution and communication of initiatives aiming at a safe and responsible animal feeding and therefore food safety.

11. Within the framework of "Specific quality", the project GCP/INT/022/FRA funded by France, aims to assist member countries in developing specific quality schemes adapted to their economic, social and cultural situation. FAO continues to collect and share information through regional seminars. In 2009 regional seminars on "Quality linked to geographical origin" were organized in Asia (Bangkok, Thailand, 8-

11 June 2009) and in Latin America (San José, Costa Rica, 29 September–1 October 2009). For more information please contact <u>www.foodquality-origin.org</u>.

12. FAO launched a new web-based Gateway to Governance in the Livestock Sector, including Food and Feed Safety and Quality (<u>www.fao.org/ag/governance-livestock.html</u>) that gathers a wide range of information: legislation, strategies and policies, standards (international and national, public and private), codes, guidelines, manuals of practices, etc. aiming at a responsible livestock sector development.

13. PAHO/WHO launched the virtual health library in food safety: <u>http://bvs.panalimentos.org</u>/<u>php/index.php?lang=es</u>.

14. As reported to the 32nd session of the Commission, FAO established a programme for emergency prevention and early warning in the area of food safety (EMPRES Food Safety) as part of its Food Chain Crisis Management Framework (FCC). The primary purpose of EMPRES Food Safety is the prevention and early warning of food safety emergencies and it is being established taking into consideration existing networks and activities in the area of prevention and early warning worldwide. To this end, EMPRES Food Safety fully engages INFOSAN activities, particularly in relation to accessing relevant information from the agriculture sector, analysing trends, forecasting and providing technical assistance to prevent emergencies. 15. The FAO Regional Office for Europe and Central Asia developed a new webpage "Quality & Origin in Europe and Central Asia - Traditional Agricultural and Food Products". The webpage is addressed to agricultural and public policy-makers, stakeholders interested in the promotion of traditional food production and rural development, producers of traditional products, academia, research institutions, competent national institutions, professionals concerned with aspects related to food safety, nutritional balance and quality of products, consumers. The aim of the page is to facilitate the access to information and good experiences, thus fostering collaboration and partnerships in increasing the presence and variety of regional traditional products associating them with sustainable rural development. The regional website was created with the support from countries that provided relevant information through an applied questionnaire. #### PART III: PLANNED INTERNATIONAL EVENTS

16. FAO's EMPRES Food Safety has provided several workshops on national food safety emergency response planning. At the regional level, EMPRES Food Safety contributed to the Global Foodborne Infections Network (GFN)/Asia Food Net workshop which was held in collaboration with WHO and FAO on national food safety emergency response planning (Bangkok, Thailand, 2-4 June 2010). The workshop used the "FAO/WHO Framework for Developing National Food Safety Emergency Response Plans" as the key training tool. At the national level, similar workshops in Bangladesh and Vietnam are scheduled for implementation in 2010. EMPRES Food Safety is considering implementing similar workshops in other regions and countries upon official request and depending on available extra-budgetary resources. 17. WHO provided eight international and three national training courses on the surveillance and detection of foodborne and other infectious enteric diseases through a network called Global Foodborne infections Network (GFN), formerly known as WHO Global Salm-Surv. The network changed name in 2009 to reflect its broader scope beyond *Salmonella*. Training sites included Barbados, Brazil, China, Costa Rica, Guam, Kenya, Madagascar, Thailand, Poland and United Arab Emirates. In these courses a total of 596 professionals from 87 countries were trained. Integrated laboratory-based surveillance is promoted and intersectorial collaboration between human health, veterinary and food-related disciplines is fostered around the world. FAO is expanding its level of collaboration in GFN. The Membership to WHO Global Foodborne Infections Network (GFN) has now reached close to 1600 individual members from more than 700 institutions in 177 member states and territories. 18. FAO and WHO, with support from the Codex Trust Fund, organized a half day seminar on "Risk Assessment of Contaminants by JECFA: What is expected from Codex members and what data is needed" for all participants at the 4<sup>th</sup> Session of the Codex Committee on Contaminants (Izmir, Turkey, 28 April 2010). The objective of the seminar was to provide information to delegations about how Codex members

and observers can get involved and contribute successfully to risk assessments performed by JECFA and the Codex risk analysis process. Presentations addressed specifically the type and quality of data that Codex members and stakeholders can generate that will subsequently allow JECFA experts to develop a risk assessment that meets the needs of CCCF for standard-setting and is reflective of the global situation. In light of the interest shown in the seminar, FAO and WHO are looking at using all opportunities to provide information to member states on risk assessment and the Codex process, particularly to developing countries and countries with economies in transition as the scientific advice provided to Codex could benefit from more input from these countries.

19. WHO assisted countries to develop educational projects and health promotion campaigns with the Five Keys to Safer Food in the context of international events such as the FIFA World Cup and Shanghai Expo. The WHO Guide on Safe Food for Travellers will be distributed to all travellers to these countries as part of their efforts to prevent foodborne diseases. WHO together with the Department of Health of South Africa adopted the Five Keys to Safer Food training course to train the food handlers in preparation of the FIFA World Cup. WHO was accepted to be part of the Shanghai Expo for 11-16 October 2010 under the theme: The Five Keys to Safer Food for a better life: Knowledge = Prevention.

20. FAO, in collaboration with the International Feed Industry Federation (IFIF) organized the  $3^{rd}$  International Feed Regulators meeting in Atlanta, USA from 25 to 27 January 2010. The event aimed at fostering dialogue and cooperation between the public and the private sector on themes of feed safety. With a view to emerging feed safety concerns, the main themes of the meeting were risk assessment and risk management in animal feed production and how they are being addressed by industry and national or regional competent authorities. All participants explored ways in which industry and competent authorities might work closer to come up with more effective and efficient solutions to ensure feed safety and discussed factors that currently restrict feed and feed ingredients trade.

#### PART IV: GLOBAL PROJECTS/INITIATIVES

21. The Governments of the Netherlands and Norway jointly supported an FAO Multi-donor Partnership Programme (FMPP) for 2009 that succeeded the PCA Norway and provided continued support to "Improved Food Safety and Quality at National Level and along the Food Chain". Activities under the 2009 programme were implemented at national and sub-regional levels and include the following countries: Bangladesh, Bhutan, Burkina Faso, Cambodia, Democratic Republic of Congo, Guatemala, Honduras, Lao PDR, Myanmar, Mali, Tanzania and Uganda.

22. FAO has distributed a questionnaire "Resource Requirements for Operation of a "Mature" National Food Control System" to a number of countries as part of a benchmarking exercise to model the costs and resources required to deliver a 'mature' food control system. The model will be used in association with a broader FAO global survey on agricultural investment to provide semi-quantitative advice on resource needs required for member countries to develop and implement effective food control systems in line with national socio-economic situations, policies and needs.

23. At its 32<sup>nd</sup> Session, the Codex Alimentarius Commission considered the issue of the impact of private food standards on member states and on the work of the Commission and agreed on the conduct of a paper to further appraise the issue. The paper, and associated workshops on the issue, will be presented at the next session of the Commission in July 2010.

24. The WHO Initiative to Estimate the Global Burden of Foodborne Diseases, launched in 2006, aims to provide reliable data on the global extent of the burden of foodborne diseases by age, sex, and region for a defined list of causative agents of microbial, parasitic, and chemical origin. The Initiative's global efforts will be complemented from the end of 2009 onwards with country foodborne disease burden studies which will provide first hand burden estimates and supplement FERG's epidemiological reviews. Country capacity in foodborne disease burden estimation, policy situation analysis and the use of epidemiological data in food safety policy-making will be strengthened through specific training opportunities and mentoring offered by the Initiative.

25. WHO finalized the Train the Trainer course on the Five Keys to Safer Food, pilot tested in South Africa, Tunisia and Belize (<u>http://www.who.int/foodsafety/consumer/keys\_training/en/index.html</u>). This course provides guidance on how to both educate and promote the adoption of safe food handling behaviours. The first module was designed to target women as women play an important role in the production and the preparation of safe food. This training course was also developed in response to the WHO Director-General's priorities to promote the health of women, particularly in developing countries (Women and health: today's evidence tomorrow's agenda [WHO global report 2009]). Modules directed to different target groups are in preparation.

26. All over the world, WHO country and regional offices collaborate with national authorities to develop Five Keys educational projects in schools, hospitals, canteens, etc. To date, more than 90 countries have implemented Five Keys to Safer Food educational projects.

#### PART V: REGIONAL/NATIONAL PROJECTS/INITIATIVES

27. Various activities were held at regional/national level. These are highlighted in Annexes 1-6 under regional/national events and projects/direct assistance to countries. Some are fully related to food safety and/or quality while others food safety is a component of a broader project.

28. The document "Report on the Codex Alimentarius and Food Safety in the Region" was presented at the 31<sup>st</sup> FAO Regional Conference for Latin America and the Caribbean (LARC 31). More information is available at <u>http://www.fao.org/docrep/meeting/018/k7339e.pdf</u>.

- FAO developed a practical manual for producers and exporters from Asia Regulations, standards and certification for agricultural exports. The publication is available in English, Thai, Vietnamese, Mandarin, Bahasa, Myanmar, Farsi, Hindi, Lao, Urdu, Tegulu and Bengali.
- FAO published in English and French the guide: "Linking People, Products and Places; a guide for promoting quality linked to geographical origin and sustainable GIs". The Spanish version will be available soon.
- FAO is publishing case studies on quality linked to geographical origin in Asia, in English, as a follow up of the regional seminar on this matter that took place in Bangkok, Thailand, June 2009.
- FAO published a guide for the development of specific quality scheme linked to geographical origin, at the local level, June 2009, in collaboration with the research network SinerGI (EU funded project), and in the framework of the French funded project GCP/INT/FRA/022.
- FAO/AGN, in collaboration with several food safety consultants, prepared a paper on the Implications of Climate Change and Bioenergy for the FAO High Level Conference on World Food Security: The Challenges of Climate Change and Bioenergy which took place at FAO headquarters in Rome, 3-5 June 2008. - "Good hygienic practices in the preparation and sale of street foods in Africa Tools for training" has been published in French and English.
- "Food Safety Risk Analysis: A guide for national food safety authorities" is now also available in French and Spanish. An accompanying CD-ROM comprising a slide presentation for training, related FAO and FAO training materials and risk analysis case studies is currently under finalization. The Russian version of the manual will be available shortly.
- The FAO/WHO guidance document for governments on the application of HACCP, in small and less developed businesses (SLDBs) was finalized. The document is now available at http://www.fao.org/ag/agn/food/quality\_haccp\_en.stm and at: www.who.int/foodsafety/publications/ fs\_management/haccp\_sidbs/en/index.html; as well as in a printed version in English, French and Spanish. The guidelines are also being translated into Chinese.
- FAO published a book on food labelling this year in collaboration with Woodhead publishers (UK). The book includes chapters on international legal considerations, Codex, nutrition labelling, allergies and food labels, environmental and social labels, organic food labels, ecolabelling and wild fisheries, geographic origin and identification labels and labelling of genetically modified/engineered foods.
