**Note 1:** The 35<sup>th</sup> Session of the Commission agreed to request JECFA to re-evaluate bST and to continue holding the draft MRLs for bST at Step 8, pending JECFA re-evaluation and CCRVDF recommendations (Ref. REP12/CAC paras 67-86).

**Note 2:** The 38<sup>th</sup> Session of the Commission recognized the validity of JECFA's risk assessments as the sound scientific basis for its deliberations on rbSTs. The Commission, as the international risk management body recognized that consensus had not been reached on the adoption of the draft MRLs. In light of this, the Commission agreed to hold the draft MRLs for rbSTs at Step 8 to provide further time to facilitate a possible consensus and that the draft MRLs would continue to be on the agenda of the CAC and open to discussion (Ref. REP15/CAC paras 49-63).
