CHAIRPERSON'S REPORT FROM THE PHYSICAL MEETING OF THE THIRD STRATEGIC PLANNING SUB-COMMITTEE

INTRODUCTION

A physical meeting of the third strategic planning sub-committee of CCEXEC was held on 9 February 2020 at Domaine des Penthes, Geneva, Switzerland and was open to all members of CCEXEC.

AGENDA

In order to progress work in line with the scope set out in the sub-committee's terms of reference, the sub-committee adopted the following agenda, in line with the proposal in section 2.2 of the interim report to CCEXEC781:

- i. reviewing the work plans developed by the Regional Co-ordinating Committees and, in particular, identifying activities that are common across more than one region and the potential for collaborative, inter-regional working;
- ii. discussing the commissioning of inputs from other Codex actors, including but not limited to: Members and Observers; parent organizations; and Chairpersons of subsidiary bodies;
- iii. reviewing proposals to be made by the Codex Secretariat on activities to be undertaken in 2020-2021 to support delivery of strategic goal 5, and determining the role that CCEXEC should take;
- iv. identifying remaining gaps and challenges in the development of a 2 year work plan for implementation of the Strategic Plan 2020-2025;
- v. proposing next steps for the completion of the work plan to be presented to CAC43.

The sub-committee agreed that the output from its meeting should be a summary of the sub-committee's discussion and any conclusions, to be drafted by the Chairperson and submitted as a CRD to CCEXEC78.

Reviewing the work plans developed by the regional co-ordinating committees

Each of the six FAO/WHO Coordinating Committee meetings, which took place between September and November 2019, aimed to develop prioritised work plans, setting out the activities that would be undertaken in the region in 2020-2021 to support implementation of the Strategic Plan 2020-2025 adopted by CAC42, in each case using a common process as set out in CCEXEC 20/78/6. The sub-committee noted that four of the six Regional Co-ordinating Committees had completed their discussions and the outputs from these four committees are collated in Annex I. The two remaining regions were close to complete their discussions. The Codex Secretariat reminded the sub-committee that the guidance given to each of the Regional Co-ordinating Committees was to look at priority areas to address in the next two years, noting the inherent difficulties in planning for the full six-year period of the Strategic Plan and the finite resources at the disposal on member countries in each region. This was illustrated by the Regional Co-ordinator for Africa who noted that the region would be interested to undertake activities relating to strategic goal 2 but recognised that building awareness of Codex was a pre-requisite and should be the focus for initial action, to lay the groundwork for subsequent activities.

The Regional Co-ordinator for Latin America and the Caribbean noted that the in-session working group established at the Regional Co-ordinating Committee for that region had identified strategic goals 2 and 4 as an appropriate focus for activities in that region in 2020-2021, but had been unable to finish its work due to the

suspension of the meeting. CCLAC21 has been reconvened, working by correspondence, in order to complete its agenda including finalisation of it activities to support implementation of the Codex Strategic Plan 2020-2025.

The Member for the South West Pacific, speaking on behalf of the Regional Co-ordinator for North America and the South West Pacific, noted that an electronic working group had been established by that Regional Co-ordinating Committee to consolidate the work undertaken in that committee. The Codex Secretariat noted that the members had prioritized Goals 1, 2 and 3; identified activities relating to objectives 1.1, 1.2, 2.1, 2.3, 3.1 and 3.3 and that the work was near conclusion.

The Chairperson of the sub-committee circulated an initial analysis, which sought to identify priority activities that had been proposed by more than one region. The Chairperson of the Codex Alimentarius Commission suggested that although it was a good strategy to identify common activities and avoid duplication, it was important that any initiative for inter-regional collaboration on priority activities was owned by the regional coordinators and respected any relevant regional differences.

The Representative of WHO called attention to, and circulated details of, the food safety resolution that had been adopted by the WHO Executive Board. There had been no objections from any member countries and so this resolution was likely to be adopted unmodified by the World Health Assembly at its meeting in May 2020. The Representative of WHO noted that, in addition to actions for WHO, the resolution contained thirteen actions addressed to member countries, many of which are closely aligned with the activities set out in the work plans of the Codex regions. WHO will be due to report back on actions undertaken, including by member countries, to the 75th session of the World Health Assembly in 2022, which would follow the next session of each Regional Co-ordinating Committees at which activities undertaken at the regional level would be reviewed.

The sub-committee concluded that CCEXEC should:

- note the work plans (being) developed by each of the Regional Co-ordinating Committees and welcome the focus on priority activities to be undertaken in each region from now, through 2020 and 2021;
- note that it will be for Regional Co-ordinators to lead on the co-ordination of these activities, including
 activities that may benefit from inter-regional collaboration, where appropriate; and
- note the general alignment of activities proposed to support implementation of the Strategic Plan, with actions addressed to member countries within the food safety resolution that we anticipate will be adopted by the World Health Assembly.

Commissioning inputs from other Codex actors

Member and observers

The sub-committee noted that member countries have contributed to the process of elaborating regional work plans to support implementation of the Strategic Plan. The sub-committee took the view that capturing the other activities being undertaken by member countries and observers may provide a more complete picture of the range of activities that support delivery of Strategic Plan outcomes and facilitate new collaborations. The sub-committee also acknowledged that this would however be a challenging task for both the sub-committee and for member countries, given the significant number and range of activities taking part in ministries, countries, regions and with a range of donors.

The sub-committee concluded that CCEXEC should not attempt to seek and collate this information from member countries and observers, but noted that where member countries, observers or other Codex actors volunteered this information we should remain open to its inclusion in the work plan to support implementation of the Strategic Plan, where appropriate.

Parent organisations

The sub-committee noted that FAO and WHO undertake a range of activities that contribute directly or indirectly to the achievement of the outcomes set out in the strategic plan, and that these activities are set out, for example, in the regular reports of FAO and WHO on scientific support, capacity development and other matters arising to the Codex Alimentarius Commission and its subsidiary bodies. There was some support for more explicit cross-reference from these activities in FAO and WHO reports to the strategic goals or objectives in the Strategic Plan that they might support.

A member of the sub-committee noted the high level of engagement with parent organisations at headquarters level and asked how this could best be cascaded to regional and national offices. The Representative of WHO noted that current work to streamline messages, together with the WHO reorganisation and World Health Assembly resolution which provide a new focus for nutrition and food safety work, presented opportunities

which, in order to be realised, needed active engagement of health ministries at country level. The Representative of FAO noted that communication channels work reasonably well and that although capacity and expertise will always be an issue for FAO national offices, this may be mitigated where countries flag with headquarters the areas where they are seeking support from FAO national offices.

The sub-committee concluded that CCEXEC should:

- invite the chairperson of the sub-committee to work together with representatives of FAO and WHO
 with the aim of ensuring that, either in the reports from FAO and WHO to future sessions of CAC or
 by other means where appropriate, there are cross-references from activities in those reports to the
 strategic goals or objectives in the Strategic Plan that they might support;
- note that effective collaboration with FAO and WHO regional and national offices required active
 engagement of national agriculture and health ministries and a signal from the member country to
 FAO and/or WHO at the headquarters level regarding national activities for which support was sought.

Chairpersons of subsidiary bodies

The sub-committee noted that members of CCEXEC hold informal discussions with the chairpersons of subsidiary bodies, either collectively through ad hoc retreats and workshops, or through the regular meetings that the Chair and Vice-Chairperson of the Commission hold with the chairpersons of subsidiary bodies. The sub-committee noted that these demonstrate the valuable insights that the chairpersons have into the practical operation of Codex and how efficiency and effectiveness may be improved.

The sub-committee returned to this issue in its discussions below.

Activities to be led by the Codex Secretariat to support delivery of strategic goals 3 and 5

The Codex Secretariat presented a range of proposals, which would be subject to resource availability within the biennial budget, to the sub-committee for its consideration.

Strategic goal 3

The Codex Secretariat noted that the Codex-wide communications plan, which will be discussed by CCEXEC, and the communications plan adopted by Regional Co-ordinating Committees at their meeting in 2019 all support delivery of objective 3.1 and should be appropriately captured in the work plan to support implementation of the Strategic Plan. The sub-committee agreed, noting the important role of communications activities in increasing awareness and impact.

The Codex Secretariat noted that activities to support achievement of objective 3.3 in relation to recognising the impact of Codex standards requires further thought and planning. Noting the long-term ambition to be able to describe the impact that use of Codex standards have on outcomes such as reducing foodborne illness, but recognising the inherent complexity in such a task, the sub-committee recalled that the outcome we were aiming to deliver in the strategic plan was relatively modest. The sub-committee noted and welcomed the activity proposed by the Codex Secretariat for the next two years relating to development of several narrative stories that start to illustrate the impact of the use of Codex standards, with input from member countries as appropriate. The sub-committee also looked forward to the consideration of a discussion paper on monitoring the implementation of Codex standards by CCGP32 and noted this may also contribute to addressing this objective. Providing Members with opportunities to consider appropriate means to measure impact of Codex was noted as being important

Strategic goal 5

The Codex Secretariat proposed for discussion the following priority activities to support objective 5.1 relating to supporting the work of secretariats, host countries and chairs of subsidiary bodies:

- strengthening the critical review process, noting its importance;
- improving the efficiency and ease of use of IT infrastructure, noting the increasing use made of this infrastructure by electronic corking groups;
- exploring and piloting how machine translation and other technology may support the conduct of Codex business in a wider range of languages, noting that this would support effective participation of member countries;
- tracking Codex standards under active review and revision.

The sub-committee supported the prioritisation of the first three areas, and in particular the strengthening of the critical review process, and noted that work to track Codex standards under active review and revision would have a lower priority, unless the CCEXEC concluded in its forthcoming discussion of the periodic review of standards that it should be a higher priority.

The Codex Secretariat proposed that, to support objective 5.2, it would continue to build on activities undertaken in recent years, primarily through annual workshops, to commence in March 2020, alternating between meetings of host secretariats and meetings of chairpersons of subsidiary bodies. The Codex Secretariat noted that CAC43 will confirm new co-ordinators for five of the six Codex regions, and acknowledged the importance of facilitating the transition from the current co-ordinators to the new co-ordinators. The Codex Secretariat therefore intends to host a workshop for current and new co-ordinators following CAC43. The Codex Secretariat further proposes to work with host country secretariats to complete guidance for host country secretariats, and to continue to supplement the existing handbook for chairpersons of Codex committees. The sub-committee supported these proposals and, in relation to guidance for chairpersons of subsidiary bodies, welcomed the inclusion on the agenda for CCEXEC this week on a discussion on dealing with unexpected interruptions to Codex meetings.

The sub-committee also noted that the Codex Secretariat would shortly be completing the outstanding action from the Strategic Plan 2014-19 to produce guidance to support the work of chairs of electronic working groups. The Codex Secretariat will present this work to CCEXEC79, which may then consider whether further activities on this issue are a priority for 2020-2021.

Identifying gaps and challenges

The sub-committee noted the need to capture activities that may be undertaken by subsidiary bodies other than the Regional Co-ordinating Committees and agreed that the Chairperson of the sub-committee should canvass the chairpersons of these committees for input, where appropriate.

Next steps for the completion of the work of the sub-committee

The sub-committee agreed that it, and CCEXEC, should aim to complete this work in a timely manner, agreeing a report and forwarding it to the Codex Secretariat no less than two months before CAC43.
