

## JOINT FAO/WHO FOOD STANDARDS PROGRAMME AD HOC CODEX INTERGOVERNMENTAL TASK FORCE ON ANTIMICROBIAL RESISTANCE Seventh Session Opening Remark

Ladies and gentlemen,

WHO picked AMR as one of the ten threats to global health this year.

Just like climate change which is also included in the list,

AMR can put more people at risk in the future if we don't make harmonized efforts.

It has been four years since WHA adopted the resolution that stresses FAO-WHO-OIE tripartite cooperation for fighting against AMR in 2015.

Over the last few years, international cooperation in fighting AMR has been stepped up.

- UN Interagency Coordination Group for AMR, IACG, has published recommendations report.
- Following the recommendations, the Joint Tripartite Secretariat on AMR has been established.
- AMR Multi-Partner Trust Fund has been launched to scale up efforts to support countries to counter the immediate threat of AMR.

The Republic of Korea launched its national action plan in 2016 for protecting public health by optimal use and reduced use of antimicrobials and control of spread of drug-resistant bacteria.

Korea's national action plan includes improving farm sanitation and bio-security for infection prevention and requires professionals' prescription for some critically important antibiotics.

All stakeholders in the food chain, from farm to table are making an effort to tackle AMR.
