BACKGROUND

1. The 46th Session of the Codex Committee on Food Additives (CCFA36) agreed that the Circular Letter requesting proposal for new and/or revision of food additives provisions in the GSFA would include a form for the submission of proposals, which would clearly identify the seven criteria for initiation of work as outlined in the *Procedure for Consideration of the Entry and Review of Food Additives Provisions in the GSFA*.¹ (Ref. REP14/FA para. 98).
2. CCFA48 agreed to forward the revised food category 01.1 (Fluid milk and milk products) of the GSFA and its subcategories to CAC39 for adoption and noted that proposals for inclusion of food additive provisions in the new food category 01.1.2 "Other fluid milks (plain)" should be submitted in response to the CL requesting proposals for new and/or revision of adopted food additive provisions (Ref. REP16/FA paras 85(i), 86 and 102 (iii)).
3. Replies to this CL, will be compiled, by the Secretariat, in a working document to be considered by the Physical Working Group on the GSFA, which will make recommendations on their inclusion in the GSFA at Step 2.

REQUEST FOR INFORMATION AND COMMENTS

4. Members and Observers, as directed above, are invited to submit proposals for:
 - a. new proposals for entry of food additives provisions in the GSFA;
 - b. revision of adopted food additives provisions in the GSFA;
 - c. food additive provisions in the new food category 01.1.2 "Other fluid milks (plain)".
5. Proposals should be submitted by using the attached form (Annex 1) before the deadline indicated above.
