- 13. Last Friday we launched the AMR Multi-Stakeholder Partnership Platform, under the Quadripartite umbrella and the leadership of FAO that will bring all relevant voices and mobilize action to preserve antimicrobials as lifesaving medicines across all sectors.
- 14. Finally under FAO's Chair, the One Health Quadripartite developed the One Health Joint Plan of Action, launched in October 2022.
