

BACKGROUND

1. Definition: xi. the use of the word Public in "Legislation includes acts, regulations, requirements or procedures, issued by competent public authorities, related to foods and covering the protection of public health, the protection of consumers and conditions of fair trading. (CXG 47-2003).	
" Comment - replace the word public to Competent authority;	
Rationale: for consistency with definition of competent authority, otherwise public authority should also be defined. Competent Authority covers government or public authority.
