IMPLEMENTATION OF THE CODEX STRATEGIC PLAN 2020-2025

Report of the in-Session Working Group

1. INTRODUCTION

- 1.1. An in-session working group was established by CCEURO32 to consider working document CX/EURO 22/32/07 and other relevant information¹ when preparing recommendations for consideration by the Plenary on the activities to be implemented in the region in the period 2022-2023 to support implementation of the Codex Strategic Plan 2020-2025.
- 1.2. The working group was chaired by Germany. The Chairperson recalled the importance of the Codex core values and that all Members had a responsibility for implementation of the Strategic Plan 2020-2025 at global, regional and national level. The Chairperson further highlighted that the plan should be ambitious yet realistic and allow for sufficient flexibility while the region would need to recover from the COVID-19 pandemic.

2. SUMMARY OF DISCUSSIONS

2.1. The discussions was undertaken in two phases.

Phase 1: Identification of the priority goals for CCEURO

- 2.2. Members were asked to consider prioritizing Strategic Goals 3 and 4 as Goals 1 and 2 were addressed in the regional work plan 2020-2021. Goal 5 was not considered as CCEURO is not identified as one of the responsible parties for this goal.
- 2.3. The WG agreed to focus the work plan on Goals 3 and 4, and highlighted the need to also address emerging work related to "new food sources" which relates to Goal 1.

Phase 2: Identification of activities

- 2.4. Members considered the proposed activities contained in CX/EURO 22/32/CRD2. In the discussion, Members highlighted the need to connect with other international organizations as regards to the promotion of food safety and Codex standards when working on the transformation of food systems (priority objective 3.3) and the importance of facilitating broader participation of Codex Members in the European Region in Electronic Working Groups (EWGs) (priority objectives 4.2 and 4.3). This can be facilitated when discussing the future of Codex working modalities at CAC45.
- 2.5. Members noted that there were no specific activities related to communication in the proposed regional work plan but that the regional communications work plan for the period 2020-2025 was still valid (Table 2).

3. CONCLUSIONS AND RECOMMENDATIONS

- 3.1. The WG considered that Table 1 represented an achievable and impactful regional contribution to the implementation of the Codex Strategic Plan 2020-2025.
- 3.2. CCEURO32 is invited to:
 - i) consider and agree with the priority goals and objectives identified by the working group;
