

# JOINT FAO/WHO FOOD STANDARDS PROGRAMME CODEX COMMITTEE ON PESTICIDE RESIDUES

#### ESTABLISHMENT OF THE CODEX SCHEDULES AND PRIORITY LISTS OF PESTICIDES

(prepared by Australia)

Noting agenda paper CX/PR 18/50/13, consideration of the following is required to finalise the Proposed 2019 Schedule of JMPR Evaluations:

#### A. NEW COMPOUNDS

- The proposed schedule lists 8 compounds with 'pyrasulfatole' given a reserve status.
- JMPR seeks an additional reserve compound from the 2020 new compound priority list.

#### B. NEW USES AND OTHER EVALUATIONS (EXTRAORDINARY MEETING)

• The proposed 2019 schedule for the extraordinary meeting lists 19 nominations. There is one available space to reach the quota of 20.

#### C. NEW USES AND OTHER EVALUATIONS (NORMAL MEETING)

- The proposed 2019 schedule of new uses and other evaluations lists 11 nominations for which national registration / product label are confirmed.
- The registration status for nominations (penthiopyrad, cypermethrin, tolfenpyrad, buprofezin, acetamiprid and imidacloprid) are now required for confirmation of a place on the proposed schedule.
- Thirteen nominations seeking Codex MRLs for spices are included in the Proposed Schedule.

### D. PERIODIC REVIEW

- The Proposed 2019 Schedule for Periodic Review contains 10 compounds. The compounds carbofuran / carbosulfan, dimethoate, tolclofos-methyl and clethodim are supported.
- At this stage, six compounds aldicarb, amitraz, azinphos-methyl, dicloran, fenarimol and phosalone
  do not appear to be supported by a manufacturer and most of these pesticides are the subject of
  public health concerns.
- Further, JMPR advise that a data package was not lodged in support of the compound bromopropylate, which was scheduled for 2018 periodic review and is the subject of a public health concern.
- The Committee is advised that a commitment of members / observers to provide support / data for the periodic review of the seven unsupported compounds is required prior to CCPR51. If this occurs, the 4-year rule will apply. If not, a recommendation will be put to the Committee to remove the seven compounds from the CCPR Pesticide List and all CXLs revoked.
