





# CCRVDF25

Dear participants of CCRVDF25,

Please find below the timetable for the virtual session of CCRVDF25. I look forward to welcoming you all in these challenging times. Due to the virtual nature of the meeting, I am very happy that we can accommodate more participants than in the regular physical meetings, making this CCRVDF more inclusive than ever. And we have been able to take advantage of our virtual tools to have two introductory webinars to help in preparation for our discussions. But virtual sessions also come with limitations and we will have to pay particular attention to the limited time frames available for discussion.

And we have a lot to discuss. We have the consideration of proposed draft maximum residue limits for various veterinary drugs, and discussion papers that may lead to new approaches on CCRVDF work on residues of veterinary drugs at different points on the step process. The priority list for evaluation/re-evaluation of existing or new veterinary drugs for the establishment of new or revised MRLs offers additional opportunity for work on standards to ensure the safety of food of animal origin and fair practices in the food trade. Further discussions of our work on the extrapolation of MRLs or the parallel review of new veterinary drugs may result in new processes to help furthering the development of standards. We will discuss the impact of the FAO/WHO expert meeting on the carryover of residues of veterinary drugs in feed and the results of our efforts with the Codex Committee on Pesticide Residues (CCPR) to develop common definition for edible offal; the latter will be an important item for discussing how this may impact the elaboration and harmonization of MRLs for compounds with dual uses as veterinary drugs and pesticides. I encourage Codex members to coordinate positions between your respective animal health and plant health protection agencies to aid discussion and harmonization between CCRVDF and CCPR.

Please look carefully at the proposed timetable we have developed to facilitate the consideration of the agenda items in the virtual plenary. For your preparation we will focus the discussions on the recommendations in the different papers. In this way I hope to achieve timely consensus on how to progress in this meeting and to provide guidance to all the electronic working group chairpersons for the new or continuing work for consideration by the next CCRVDF. Where there is room to make progress in the step procedure, we should as a Committee strive to keep moving forward to offer the results to the Commission. I count on Codex Members to support me in these endeavors.

You will also find some useful links on the CCRVDF25 website, such as the provisional agenda and related working documents, including relevant circular letters, reports of previous CCRVDF sessions and the information document to support discussion on the MRLs for veterinary drugs; as well as the webinars on the carryover in feed and the CCRVDF different agenda. All of this is provided to assist delegations in their preparations for CCRVDF25 and to facilitate discussions during the session.

Please also pay special attention to the guidance for Codex members and observers to facilitate the smooth running of Codex virtual meetings under the Information for Delegates also available on the CCRVDF25 webpage. This information is also useful for delegations participating in the virtual meeting of the Working Group on Priorities to be held on Tuesday 6th July.
