# **ARRANGEMENTS FOR THE SESSION**

#### **GENERAL INFORMATION**

1. The Twenty-seventh Session of the Codex Alimentarius Commission will be held at the International Conference Centre of Geneva (Salle II), 15 rue Varembé, Geneva, Switzerland. The opening meeting will begin at 10.00 hours on Monday 28 June 2004. Registration will commence at 7.30 hours.

2. The Session is open to Member Nations and Associate Members of FAO and WHO which are members of the Commission, and to observers. Member Nations and Associate Members of both Organizations which are not members of the Codex Alimentarius Commission may attend as observers. The Session is also open to the public subject to the availability of seats, and to the media.

3. Expenses incurred in connection with attendance at sessions of the Commission and its subsidiary bodies and travel of delegations of the Members of the Commission and of the observers shall be borne by the governments or organizations concerned. Participants are also reminded that they are responsible for making their own hotel arrangements.

4. Members of the Commission attending the Session shall have one representative, who may be accompanied by one or more alternates or advisers. No delegate may represent more than one Member Nation or Associate Member.

5. Registration facilities will be available from 07.30 hours at the Reception Desk in the main entrance hall, on the ground floor of the same building.

6. Persons intending to participate at the Session may wish to refer to the **Guide for Delegates** for detailed information about facilities and services available in the CICG.

For reasons of economy, this document is produced in a limited number of copies. Delegates and observers are kindly requested to bring it to the meetings and to refrain from asking for additional copies, unless strictly indispensable.
