ACTIVITIES OF FAO AND WHO COMPLEMENTARY TO THE WORK OF THE CODEX ALIMENTARIUS COMMISSION, INCLUDING CAPACITY BUILDING

INTRODUCTION

1. This paper describes FAO/WHO activities in the areas of capacity building and the provision of scientific advice implemented since the 26th Session of the FAO/WHO Coordinating Committee for Europe (CCEURO) which are complementary to the work of the Codex Alimentarius Commission.

TECHNICAL CAPACITY DEVELOPMENT OVERVIEW

- Under their respective mandates, goals and workplans, FAO and WHO are engaged in a range of food safety and quality capacity development activities at national and regional levels. These capacity development activities directly support the Codex Strategic Plan 2008–2013; in particular, activities 1.7, 2.6 and 5.4.
- 3. FAO and WHO capacity development activities are generally aimed at:
 - upgrading the capacity of countries with transition economies in food safety, quality control and quality assurance and supporting their effective participation in the work of Codex;
 - enhancing the respective roles of the agriculture and health sectors, trade and industry in ensuring the safety and quality of the food supply; and
 - strengthening cooperation and collaboration between FAO and WHO and partner organizations, in the field of food safety and quality.
- 4. Since the last session of the FAO/WHO Coordinating Committee for Europe, FAO and WHO (either jointly or together with partner organizations and donors) have commenced or are continuing to work with countries of the region on a range of activities (including direct technical assistance projects on food safety and quality, regional projects and events addressing food safety issues). Detailed information is provided in paragraph 10 below. Detailed information on capacity building activities and initiatives of global relevance was provided to the 33rd Session of CAC and is available in CX/CAC 10/33/15 Add.1 (ftp://ftp.fao.org/codex/cac/cac33/ cac33_15_add1e.pdf). The working paper provides information of relevance to the all regions and describes the range of supporting materials (e.g. guidelines, manuals and online resources), global information exchange systems, international events and global projects which have been delivered or initiated since the last session. Issues of relevance include 1. Ongoing work strengthen efforts through INFOSAN and EMPRES Food Safety programme to support countries' in dealing with emerging food safety issues, and managing food safety emergencies; 2. Availability of training materials to assist countries in implementing relevant Codex texts related to the food safety assessment of foods derived from recombinant DNA plants, and maintenance of the data set for food safety assessment for r-DNA plants within the International Portal on Food Safety, Animal and Plant Health (www.ipfsaph.org); 3. Continued support to countries on surveillance and detection of foodborne and other infectious enteric diseases through the Global Foodborne infections Network (GFN), formerly known as WHO Global Salm-Surv (www.who.int/gfn) and 4. The undertaking of country case studies to support the WHO Initiative to Estimate the Global Burden of Foodborne Diseases (FERG). Special Focus on Regional Initiatives

- 6. Recent joint FAO/WHO capacity-building activities organized by the Codex Trust Fund in collaboration with Codex partners appear in the annual reports and progress reports of the Codex Trust Fund which were submitted to the 64th Session of the CCEXEC and the 33rd Session of the CAC. Specific to the forthcoming 27th Session of CCEURO, FAO and WHO with funding from the CTF are planning a pre-CCEURO workshop on 4 October 2010, to discuss the risk analysis paradigm: with emphasis on control and prevention of food safety hazards. All CCEURO members are invited to participate.
- 7. FAO Regional Office for Europe and Central Asia developed a new webpage "Quality & Origin in Europe and Central Asia Traditional Agricultural and Food Products". The webpage is addressed to agricultural and public policy-makers, stakeholders interested in the promotion of traditional food production and rural development, producers of traditional products, academia, research institutions. It is also of interest to competent national institutions, professionals concerned with aspects related to food safety, nutritional balance and quality of products, consumers. The aim of the webpage is to facilitate the access to information and good experiences, thus fostering collaboration and partnerships in increasing the presence and variety of regional traditional products associating them with sustainable rural development. The regional website was created with the support from countries that provided relevant information through an applied questionnaire. - 8. FAO and WHO, with support from the Codex Trust Fund, organized a half day seminar on "Risk Assessment of Contaminants by JECFA: What is expected from Codex members and what data is needed" for all participants at the 4th Session of the Codex Committee on Contaminants (Izmir, Turkey, 28 April 2010). The objective of the seminar was to provide information to delegations about how Codex members and observers can get involved and contribute successfully to risk assessments performed by JECFA and the Codex risk analysis process. Presentations addressed specifically the type and quality of data that Codex members and stakeholders can generate that will subsequently allow JECFA experts to develop a risk assessment that meets the needs of CCCF for standard-setting and is reflective of the global situation. In light of the interest shown in the seminar, FAO and WHO are looking at using all opportunities to provide information to member states on risk assessment and the Codex process, particularly to developing countries and countries with economies in transition as the scientific advice provided to Codex could benefit from more input from these countries.
- 9. FAO plans to hold a training workshop in Budapest, Hungary in November 2010 on the establishment of MRL and assessment of the risk from pesticide residues. The general objectives of the training are (1) to strengthen the capabilities of scientists from developing and transition countries in the techniques of pesticide evaluation for the establishment of MRLs; (2) to update their knowledge of the assessment of risks associated with dietary intake of pesticide residues and (3) to respond to the requests of developing and transition countries to play a great role in the Codex MRL process.

- 11. Looking ahead, priorities for the coming year in the region, which may be implemented jointly by FAO and WHO, or in association with other partner organizations, aim at strengthening national food control systems in European countries, including:
 - providing expertise in the drafting of Codex compliant laws, regulations and standards;
 - building the competent authority capacity of food inspection/certification services;
 - strengthening monitoring chemical and microbiological contamination in the food chain
 - strengthening surveillance of foodborne disease
 - promoting risk-based food inspection systems;
 - enhancing food analysis capacity;
 - strengthening official food safety systems through the use of the risk analysis framework including risk assessment of food hazards;
 - targeted training for food safety officials and technical staff (food safety managers, food inspectors, and food analysts) in carrying out their respective duties;
 - supporting national Codex programmes (including Codex Contact Points and National Codex Committees) to facilitate effective participation in Codex and providing tailored Codex training to further enhance participation in Codex activities at regional and national levels;
 - building capacity of small and medium size enterprises to implement food quality and safety standards;
 - developing tools and training materials to assist food safety and quality control activities; and
 - strengthening regional and international food control information exchange and cooperation activities.
 - promoting proper and timely food safety risk communication to all relevant stakeholders
 - cost-efficient and good collaboration between the public health, veterinary and food sectors.

- 12 Capacity development activities at national and regional levels are implemented according to organization-wide strategic planning, as well as in response to direct requests from member countries.
- 13. The membership of CCEURO is invited to engage with FAO and WHO to provide feedback on:
 - o ongoing FAO and WHO activities to strengthen food safety and quality in the region
 - o priority needs at national and regional level which require further support from FAO and WHO.
