CRITICAL REVIEW FOR THE ELABORATION OF CODEX STANDARDS AND RELATED TEXTS - MONITORING OF STANDARDS DEVELOPMENT

1. In the framework of the Critical Review, the present document considers all items of work which are in the process of elaboration in Codex Committees. Draft Standards and Related Texts submitted to the Commission for Adoption are presented under Agenda Item 2 (b). New work items are presented under Agenda Item 2 (c).

2. The 63rd Session of the Executive Committee (2009) agreed that a list of discussion papers should be included in the document on monitoring for information purposes only, in order to present a complete view of the workload of each Committee, but would not be discussed as such. A list of discussion papers related to potential new work was therefore included, when applicable.

3. When recommendations have been made by previous sessions of the Executive Committee for specific items of work, they are also mentioned in the notes.

4. The format included in the Strategic Plan 2008-2013 was used in the presentation of the critical review, as follows. The Job Identification Number provides information on standards and related texts that were approved as new work from 2004 onwards. The first column in the Table indicates either the Identification Number, or the year when new work was approved, or the year when work actually started, as applicable. The target year is the year by which the text is to be adopted at Step 8, as agreed by the Commission on the basis of the project document (from 2004 onwards), or the date specified by the Committee at another stage of the process, where applicable.

5. The output codes are specified in Part 2 of the Strategic Plan: 1.1: Review and develop Codex standards and related texts for food safety; 1.2: Review and develop Codex standards and related texts for food quality; 1.3: Review and develop Codex standards and related texts for food labelling and nutrition; 1.4: Review and develop Codex standards and related texts for food inspection and certification, and methods of sampling and analysis. Scientific advice is mentioned when it has been required and when it has been provided. The comments received from Chairpersons or host countries of the committees concerned are included in the Tables.

6. In accordance with Rule V.2 of the Rules of Procedure and with Paragraphs 5-8 in Part 2 "Critical Review" of the Procedures for the Elaboration of Codex Standards and Related Texts, the Executive Committee is invited to review the status of development of draft standards against the timeframe agreed by the Commission. In particular, the Executive Committee may propose an extension of the time frame; cancellation of work; or propose that the work be undertaken by a Committee other than the one to which it was originally entrusted.

7. To facilitate the conduct of monitoring progress of standards development, the 58th Session of the Executive Committee (June 2006) agreed on the following criteria to be applied:

- When progress on a standard is delayed due to the need for scientific advice, the Executive Committee could encourage FAO and WHO to schedule an expert consultation to provide such advice in a timely manner, and recommend suspension of work until such time as scientific advice became available;
- When scientific advice has been provided and a standard has been under consideration for more than five years, the Executive Committee should urge the Committee concerned to take action within a specified timeframe;
- When an item has been considered for several sessions without any progress and there is no prospect of reaching consensus, the Executive Committee could propose suspension of work at a particular Step in the Elaboration Procedure for a specified period of time or discontinuation of work, or corrective action to be taken to achieve progress, fully taking into consideration the information provided by the subsidiary body concerned.¹

Comments by the Chairperson:

• <u>PROPOSED DRAFT GUIDELINES FOR CONTROL OF SPECIFIC ZOONOTIC PARASITES IN MEAT: TRICHINELLA SPIRALIS AND</u> <u>CYSTICERCUS BOVIS</u>. The Committee agreed to continue working in parallel on the development of the documents on *Trichinella* spp. and *Taenia saginata /Cysticercus bovis*. The Committee agreed to establish an electronic working group, co-chaired by the European Union and New Zealand and working in English only, to further develop the two proposed draft guidelines taking into account the above discussion and the development of the OIE work on the revision of Chapter 8.13 "Infection with *Trichinella* spp" of the Terrestrial Animal Health Code, where applicable. In order to further progress this work, the Committee agreed to convene a physical working group, led by the European Union and New Zealand, to meet immediately prior to its next Session, to review the comments received at Step 3 and facilitate the discussion at the Plenary, subject to OIE adoption of the revision of Chapter 8.13. The Committee agreed to return the proposed draft Guidelines to Step 2 for revision by the electronic working group, circulation for comments at Step 3 and consideration by the next Session of the Committee. The Committee did agree that the document will not be forwarded for adoption until CCFH has had an opportunity to review the OIE revisions to the Terrestrial Animal Health Code relative to *Trichinella* spp. • <u>PROPOSED DRAFT REVISION OF THE CODE OF HYGIENIC PRACTICE FOR SPICES AND DRIED AROMATIC PLANTS (CAC/RCP 42-1995)</u>. The Committee agreed to establish an electronic working group led by the United States of America, working in English only, to redraft the Code taking into account the decisions taken at the Session, and the written comments submitted. The Committee noted the provisional offer of the Delegation of India to co-chair the electronic working group, pending confirmation of their government, which was subsequently received. The Committee agreed to return the proposed draft renamed Code to Step 2 for redrafting by the electronic working group, circulation for comments at Step 3 and consideration by the next Session of the Committee.

Other NRVs than those forwarded for adoption, including a NRV for protein, will be considered by an electronic working group (eWG). CCNFSDU will continue its work on these NRVs based on the recommendations by the eWG at the next session.

Proposed Draft Revision of the Codex General Principles for the Addition of Essential Nutrients to Foods (CAC/GL 9-1987) (Step 2/3)

At its 34th Session CCNFSDU considered the proposals by an electronic working group (eWG) and discussed extensively the critical issues. The Committee recognized that it was not possible to proceed further and therefore agreed to establish an eWG to consider the comments and to prepare a revised draft for comments and consideration at the next session. The Committee also agreed to convene a physical working group prior to the next session to consider the revised draft and the comments at Step 3.

Proposed Draft Amendment of the Standard for Processed Cereal-Based Foods for Infants and Young Children to Include a New Part B for Underweight Children (Step 2/3)

CCNFSDU considered the draft for a new Part B for underweight children proposed by an electronic working group (eWG) and discussed in detail the scope of the proposed draft. The Committee agreed to establish an eWG to revise the proposed draft, especially the scope. The Committee agreed to return the Proposed Draft Amendment for redrafting by the eWG, comments at Step 3 and consideration at the next session.

- Principles and guidelines for the elaboration and management of questionnaires directed at exporting countries

The discussion paper will include a proposal for new work and an outline of principles and guidelines on the elaboration and management of questionnaires to address the problems faced by exporting countries due to multiple questionnaires.

- Principles and guidelines for monitoring regulatory performance of national food control systems

The discussion paper will include a proposal for new work and an outline of principles and guidance for monitoring the performance of national food control systems, to be annexed to the new Principles and Guidelines for National Food Control Systems.

- Draft amendments to Guidelines for the Exchange of Information between Countries on Rejections of Imported food (CAC/GL 25-1997)
- Revision of the Principles and Guidelines for the Exchange of Information in Food Safety Emergency Situations ((CAC/GL 19-1995).

The discussion paper will include a an outline of the proposed revision of the CAC/GL 19-1995.

Comments by the Chairperson/host country of the Committee:

- Principles and guidelines for the elaboration and management of questionnaires directed at exporting countries

The 20th CCFICS in principle supported the need for new work, however, it considered it necessary to further refine the scope of the new work before sending it to the Commission for approval. The Committee agreed that the new work should aim at providing guidance on which information might be useful to assess the exporting country's national food control system or parts thereof; that the scope of the work was on the exchange of information between competent authorities of importing and exporting countries; and that the focus of the work would initially be limited to specific areas of trade or specific products or groups of products entering the market for the first time.

- Principles and guidelines for monitoring regulatory performance of national food control systems

The 20th CCFICS supported this work as many countries are developing measures, while others had difficulties to objectively assess and continuously review and improve their national food control systems. The Committee was of the opinion that the work was a natural continuation of the just completed work on national food control systems; that the proposed timeline of three sessions to develop the document was sufficient to allow all members to actively participate and contribute to this work; and that workshops could be organised to promote understanding. The Committee considered it necessary to further refine the scope of the new work before sending it to the Commission for approval.

- Revision of the Principles and Guidelines for the Exchange of Information in Food Safety Emergency Situations (CAC/GL 19-1995)

The 20th CCFICS generally supported the proposal and made the following comments: the organizations mentioned in the document should be informed; the work should not address risk analysis, and risk management in particular, which were not within the CCFICS mandate; and the work should take into account new developments in information technology.

Prosposed Draft Standard for Fish Oils

The Committee agreed to return the proposed draft standard to Step 2 for redrafting. The Committee established an electronic working group chaired by Switzerland open to all members and observers and working in English only with the terms of reference to revise the proposed draft standard on the basis of the discussion at the session. The Committee also agreed to convene a physical working group, chaired by Switzerland, immediately prior to its next Session and working in English only, to consider the report of the electronic working group and comments submitted to the working document in order to facilitate the discussion in the plenary at the next Session.

The Committee considered the proposed draft standard on fish oils section by section and arrived at a clear direction on how to proceed on this important standard. The Committee agreed on the Scope as amended at the session, and agreed that other sections be redrafted by an electronic working group chaired by Switzerland, which will prepare a revised proposed draft on the basis of the discussion at the session. It was also agreed that a Circular Letter be issued by Codex Secretariat, requesting for information on volume and patterns of trade for different fish oils and information on quality and composition, including fatty acid profile for named fish oils.

Discussion papers

Several proposals for new work, which had been deferred by the 22nd CCFO due to lack of or insufficient data, were considered by this session. Some of these proposals still lacked in actual trade volume, regionally and internationally. Members were again reminded to comply with the relevant guidelines, namely (1) Guideline on the Application of the Criteria for the Establishment of Work Priorities (Criteria Applicable to Commodities) in the Procedural Manual; and (2) specific information required by the CCFO when proposing the addition of new oils to the Standard for Named Vegetable Oils, as agreed by the Committee at its 16th Session, 8-12 March 1999 (ALINORM 99/17).

<u>Other</u>

In response to the directive of the Commission to review the list of acceptable previous cargoes against the criteria, the Committee agreed to establish an approach to review the list on a continuous basis.
