

REPORT OF THE ELECTRONIC WORKING GROUP ON THE REVISION OF THE PROCEDURAL MANUAL

(prepared by Switzerland with the assistance of Brazil, China, Cuba, France, European Community, India, Japan, Malaysia, New Zealand, Serbia and Montenegro, Sri Lanka, Thailand, United States and ELC)

OBJECTIVES OF WORK

1. At its 38th session the Codex Committee on Food Additives and Contaminants agreed to establish an electronic Working Group¹ led by Switzerland to consider the relevant amendments to the Procedural Manual, including: i) Format for Codex commodity standards, section on food additives; ii) Relations between commodity committees and general committees, section on food additives and contaminants; and iii) Terms of reference of the Committee and to prepare a report with a first proposal of amendments to the Procedural Manual for circulation, comments and further consideration at the next session of the Committee (ALINORM 06/29/12, paras 68 and 69).

- 2. The main objective of the proposed amendments to the Procedural Manual is to align the procedures related to the elaboration of food additive provisions and the formats to be used with those changes of the Preamble to the General Standard for Food Additives (Codex Stan 192) (GSFA) which were adopted by the Commission at the 29th session (ALINORM 06/29/41, para 40; ALINORM 06/29/12, Appendix V) and those proposed changes contained in the draft *Procedures for Consideration of the Entry and Review of Food Additive Provisions in the General Standard for Food Additives* (ALINORM 06/29/12, Appendix VI; this document is referred to as draft *Procedures for Consideration*).
- 3. Appendix I provides a comprehensive synoptic table of the relevant current sections of the Procedural Manual, the new proposed texts to replace those, and comments which provide a justification for each proposal are consolidated. This is provided to facilitate a transparent and informed discussion by the

Committee. It is understood that only the column *Proposed new text* of Appendix I will be forwarded to the Codex Committee on General Principles for endorsement and subsequently to the Commission for final adoption. This consolidated proposal is also available as one single document in Appendix II.

FORMAT FOR CODEX COMMODITY STANDARDS

- 4. The Preamble of the GSFA, as adopted by the Commission in 2006, states that this standard "should be the single authoritative reference point for food additives." In practice this means that a commodity standard should, reference to Tables 1, 2 and 3 of the GSFA. However, its is recognized by the draft *Procedures for Consideration* that in exceptional cases a general reference may not be adequate and that an alternative approach may be necessary for helping to realize the mission of Codex to protect consumer health and to promote fair trade practices.
- 5. The alternative approach should be the exception. The general format of the food additive section of commodity standards should include, as a default, a reference to the GSFA. If a commodity committee proposes an alternative approach a comprehensive justification should be provided to the CCFA for consideration.

RELATIONS BETWEEN COMMODITY COMMITTEES AND GENERAL COMMITTEES

- 6. The Working Group's terms of reference mentioned only the section *Food Additives and Contaminants* (pp 93-95 of the 15th edition), however, a closer examination of the general introduction (p 92) revealed that its second and third paragraph could possibly also require some revisions; they are therefore included in Appendix I. The Working Group leaves it to the Committee to decide whether this is beyond the assigned task and shall be considered or not.
- 7. The relations between commodity committees and the CCFA shall reflect the overall principle that the GSFA is the single authoritative reference point for food additives. This includes not only the additive provisions of the GSFA's Tables 1, 2 and 3 but also the principles and guidance contained in the Preamble and, in particular, Section 3 (General Principles for the Use of Food Additives).
- 8. Based on the experience gained during recent years from discussions on the food additive provisions of several commodity standards it would be helpful if commodity committees and the CCFA discuss the approach to the commodity standard's food additive section early in the Codex standard elaboration process. Whether such discussions can take place before the commodity standards are advanced to Step 5 needs to be discussed with the Codex Secretariat and the CCGP.

TERMS OF REFERENCE

9. The new Terms of Reference for the CCFA were adopted by the Commission with the understanding that they would be examined and possibly revised at the Committee's 39th session. The Working Group studied whether the *Terms of Reference* reflect the working relationship between the CCFA and the commodity committees and concluded that this was the case. In order to distinguish more clearly between the work on the GSFA and the amendment of food additive sections in commodity standards, the Committee may wish to split the current Term a) into two separate entries.

CONCLUSION AND RECOMMENDATIONS

- 10. The proposed amendments to the Procedural Manual will be discussed by the 39th session of the CCFA taking in to account, if possible, the discussions on the *Procedures for Consideration* that will have taken place at the 24th session of the CCGP.
- 11. Depending on the results of the discussion the CCFA may wish to forward the proposed amendments directly to the Commission for adoption, send it to the Commission via the CCGP, or allow for another round of discussion within the Committee.
- 12. Since the Working group agreed that the section *Relations between commodity committees and general committees* shall describe only the relation between commodity committees and the CCFA, CCCF is asked to draft a separate section.

However, it is understood that in certain cases such a reference will not be adequate. CCFA should consider the general format items of the cross-reference to the GSFA. There are two approaches. The first would be to follow the example in the Procedural Manual for referencing the general standards for food hygiene and labelling of pre-packaged foods. For these two general standards, the PM recommends a straightforward, simple reference to these general standards. The second approach is to be more specific with explicit references to the critical elements in the GSFA, e.g., food additive functional class, food category, Tables 1, 2, or 3. The food additive functional class information is important when the standardized food and the non-standardized foods are subject to the same food category. By instructing the commodity committees to specify additives by functional classes, they can exclude food additive classes that may be appropriate in their non-standardized counterparts. Subject and commodity Committees should refer to the principles and guidelines developed by the Codex Committee on Food Import and Export Inspection and Certification Systems when developing provisions and/or recommendations on inspection and certification and make any appropriate amendments to the standards, guidelines and codes within the responsibility of the individual committees at the earliest convenient time

FOOD ADDITIVES

Codex commodity committees shall examine the General Standard for Food Additives with a view toward incorporating a reference to the General Standard. All proposals for additions or revisions to the General Standard in order to establish a reference to the General Standard shall be referred to the Codex Committee

on Food Additives. The Codex Committee on Food Additives shall consider such proposals for endorsement. Revisions of a substantive nature that are endorsed by the Food Additives Committee will be referred back to the commodity committee in order to achieve consensus between both committees at an early stage of the step procedure.

Should the Codex commodity committee consider that a general reference to the General Standard for Food Additives does not serve its purpose, a proposal should be prepared and forwarded to the Codex Committee on Food Additives for consideration and endorsement. The commodity committee shall provide a justification for why a general reference to the General Standard would not protect consumer health, ensure fair practices in the food trade or does not meet the criteria for the use of food additives established in the Preamble of the General Standard, in particular Section 3.

When considering provisions for food additives in standards, all Codex committees should follow the guidance in the Preamble of the General Standard for Food Additives, specifically Section 3. Full explanation should be provided to the Codex Committee on Food Additives for any departure from this guidance.

All provisions in respect of food additives (including processing aids) contained in Codex commodity standards should be referred to the Codex Committee on Food Additives preferably <u>before</u> the Standards have been advanced to Step 5 of the Procedure for the Elaboration of Codex Standards or before they are considered by the Commodity Committee concerned at Step 7, though such referral should not be allowed to delay the progress of the Standard to the subsequent Steps of the Procedure.

All provisions in respect of food additives contained in commodity standards will require endorsement by the Codex Committee on Food Additives, on the basis of technological justification submitted by the commodity committees and on the recommendations of the Joint FAO/WHO Expert Committee on Food Additives concerning the safety-in-use (acceptable daily intake (ADI) and other restrictions) and an estimate of the potential and, where possible, the actual intake of the food additives, ensuring conformity with the Preamble of the General Standard for Food Additives.

When forwarding a food additive section of a commodity standard for endorsement by Codex Committee on Food Additives the Secretariat should prepare a report to the Committee that includes not only the proposed provisions for food additives but also indicates the International Numbering System (INS) number, the Acceptable Daily Intake (ADI) assigned by the Joint FAO/WHO Expert Committee on Food Additives, technological justification, proposed level, and whether the additive was previously endorsed (or temporarily endorsed by the CCFA).

When commodity standards are sent to governments for comment at Step 3, they should contain a statement that the provisions "in respect of food additives are subject to endorsement by the Codex Committee on Food Additives and to incorporation into the General Standard for Food Additives."

When an active commodity committee exists, proposals for the use of additives in any commodity standard under consideration should be prepared by the commodity committee concerned, and forwarded to the Codex Committee on Food Additives for endorsement and inclusion in the General Standard. When the Codex Committee on Food Additives decides not to endorse specific additives provisions, the reason should be clearly stated. The section under consideration should be referred back to the commodity committee concerned if further information is needed, or for information if the Codex Committee on Food Additives decides to amend the provision.

When no active commodity committee exists, proposals for new additive provisions or amendment of existing provisions for inclusion in the General Standard should be forwarded directly by Codex members to the Codex Committee on Food Additives.

CODEX COMMITTEE ON FOOD ADDITIVES - Terms of reference:

- (a) to establish acceptable maximum levels for individual food additives for inclusion into the General Standard for Food Additives (GSFA);
- (b) to establish or endorse permitted maximum levels for individual food additives for inclusion into Codex commodity standards where appropriate on the basis of technological justification submitted by the commodity committees;

(c) to prepare priority lists of food additives for risk assessment by the Joint FAO/WHO Expert Committee on Food Additives;

- (d) to assign functional classes to individual food additives;
- (e) to recommend specifications of identity and purity for food additives for adoption by the Commission;
- (f) to consider methods of analysis for the determination of additives in food; and
- (g) to consider and elaborate standards or codes for related subjects such as the labelling of food additives when sold as such.
