#### ENDORSEMENT AND/OR REVISION OF MAXIMUM LEVELS FOR CONTAMINANTS IN CODEX STANDARDS

#### BACKGROUND

- 1. In accordance with the section regarding Relations between Commodity Committees and General Committees in the Codex Alimentarius Commission Procedural Manual (Tenth Edition, pages 76-78), "All provisions in respect of food additives (including processing aids) and contaminants contained in Codex commodity standards should be referred to the Codex Committee on Food Additives and Contaminants .....".
- 2. In consideration of the above and other provisions of the *Procedural Manual* concerning the relationship between commodity committees and the Codex Committee on Food Additives and Contaminants, the attached contaminant provisions are being submitted to the Committee for endorsement. This document does not include previously endorsed contaminant provisions at the same levels of use as specified in draft Codex standards recently considered by the Committee.
- 3. The following contaminant provisions of Codex standards are listed by: (i) contaminant name; (ii) proposed maximum level; (iii) PTWI (mg/kg body weight), and; (iv) notes.
