PROCESSED CHEESE (MINIMUM CHEESE CONTENT)
INCLUDING COMMENTS SUBMITTED IN RESPONSE TO CL 2001/20-MMP

BACKGROUND

At the 4th Session of the CCMMP, the Committee agreed¹ that the Codex Secretariat, in collaboration with France, the United States and IDF, would prepare a circular letter to obtain information and data on minimum cheese contents in processed cheeses as well as comments on the two alternative proposals:

The product is qualified by a cheese content, in quantity or characterization terms, and; Chees is a significant ingredient of processed cheese and cheese preparation,

and on any other relevant points.

The Committee also agreed to seek information on methods of analysis used at the national level to determine cheese content in processed cheese. It was further agreed that France, the United States and IDF would collate and present the information to the next session of the Committee so as to further examine the prospect of establishing an absolute minimum cheese content for processed cheeses or alternative approaches.

CIRCULAR LETTER CL 2001/20-MMP

Circular letter CL 2001/20-MMP was issued in July 2001, requesting information on minimum cheese contents in national legislation, and on the two alternative proposals by 1 November 2001.

20 member countries replied to the Circular Letter, as follows: Argentina, Austria, Canada, Croatia, Czech Republic, France, Germany, Hungary, Ireland, Malaysia, Netherlands, New Zealand, Poland, Romania, Slovak Republic, Spain, Switzerland, United Kingdom, United States, and Uruguay. No replies were received from international organizations. The responses of the above countries are compiled in Annex 1.
