NOTES ON THE PROVISIONAL AGENDA

Opening of the Session - The Session will be opened by the representative from the host country.

Agenda Item 1 - Adoption of the Agenda (CX/NMW 00/1). In accordance with Rule V.2 of the Rules of Procedure, the first item on the Provisional Agenda shall be Adoption of the Agenda. The Chairperson will request the Committee to adopt the Provisional Agenda as the Agenda for the Session.

Agenda Item 2 - Matters Referred to the Committee by the Codex Alimentarius Commission and/or Other Codex Committees (CX/NMW 00/2). The Committee is invited to consider matters referred to it by the Codex Alimentarius Commission and/or other Committees.

Agenda Item 3 - Proposed Draft General Standard for Bottled/Packaged Waters Other Than Natural Mineral Waters (ALINORM 99/20, Appendix II). The Document is a consequence of discussions held during the last session of the Committee. Government comments at Step 3 are presented in CX/NMW 00/3.

Agenda Item 4 - Codex Standard for Natural Mineral Waters: Limits for Health Related Substances (CX/NMW 00/4). The 23rd Session of the Codex Alimentarius Commission recognized that there was no consensus on the endorsement of levels for arsenic, barium, manganese and selenium in the Codex Standard for Natural Mineral Waters and agreed that they should be returned for further consideration to the Committee on Natural Mineral Waters as a matter of priority, following which they would be submitted to the Committee on Food Additives and Contaminants for endorsement. The Committee is invited to consider this matter based on paper prepared by the Codex Secretariat.

Agenda Item 5 - Other Business and Future Work. In accordance with Rule V of the Rules of Procedure, any Member of the Commission may propose the inclusion of specific items of an urgent matter. The Committee may propose to undertake new work which shall be in compliance with the Medium Term Objectives and subject to the approval by the Commission or its Executive Committee.

Agenda Item 6 - Date and Place of the Next Session. The Committee will be advised of the tentative date and place of the next session of the Committee.

Agenda Item 7 - Adoption of the Report. In accordance with Rule VIII.1 of the Rules of Procedure, the Committee shall adopt the report of its Seventh Session, based on a draft provided by the Secretariat.
