#### **IMPLEMENTATION OF THE CODEX STRATEGIC PLAN 2020-2025**

(Prepared by the Coordinator for North America and South West Pacific and the Codex Secretariat)

#### 1. Introduction

- 1.1 The FAO/WHO Coordinating Committee for North America and the South West Pacific at its fifteenth Session (CCNASWP15, 2019)¹ discussed the roadmap to implementation of the Codex Strategic Plan (2020-2025) and established an in-session working group (WG) to address the request from the Executive Committee of the Codex Alimentarius Commission (CCEXEC) to the regions to provide details on the activities it would undertake to support the implementation of the Strategic Plan 2020-2025 during 2020-2021.
- 1.2 The WG prioritized activities under Goals 1, 2 and 3 for the next two years for the region and identified the following activities:
- Goal 1: strengthening the National Codex Committee (NCC); improving the performance of the CCPs by assigning qualified staff to that position; providing sufficient funding and resources; improving the linkages with the Codex Secretariat; and establishing and participating in the Pacific Islands EWG.
- Goal 2: hosting a regional workshop with support from FAO and WHO on the use of expert scientific advice in the development of Codex standards; developing and implementing a workplan to generate relevant data to elaborate Codex standard, specifically referring to scopoletin in the regional standard for fermented noni fruit juice; and promote sustainable funding for scientific advice for use by Codex.
- Goal 3: deal with lack of effective enforcement of Codex standards; coordination among relevant authorities; awareness of rules and responsibilities; ownership; and resources.
- 1.3 CCNASWP15 concluded that CCNASWP in the implementation of the SP would focus on the implementation of activities aimed towards achieving Goals 1, 2 and 3 and agreed to establish an electronic WG (EWG), chaired by Vanuatu and co-chaired by Fiji, to a) refine the activities to be undertaken in the region to support the implementation of the SP over the next two years taking into consideration the discussions at CCNASWP15; b) include the additional information required in the workplan on responsibilities, targets and approach for monitoring; and c) submit the proposed workplan for CCNASWP to the Codex Secretariat through the Regional Coordinator by 31st December 2019, for incorporation into the overarching workplan for implementation of the SP by the Strategic Planning sub-committee of CCEXEC. CCNASWP15 encouraged all Member countries to participate in the EWG to ensure that the work plan was realistic and achievable in the next two years while also reflecting on the priority needs of the region.
- 1.4 CCNASWP15 was also presented with the draft Regional Communications Workplan 2020-2025<sup>2</sup>. CCNASWP15 adopted this workplan and agreed to work towards its implementation and liaise with the Codex Secretariat primarily through the Coordinator to execute the Communications Workplan between CCNASWP15 and CCNASWP16.

## 2. Further process in developing the Regional Workplan for 2020-2021

2.2 The period 2020 and 2021 was an unfavourable period not only in the NASWP region but globally as the COVID-19 pandemic took its toll on people's lives and greatly impacted countries' economy. However, despite the global challenges and the need to postpone most Codex meetings, Codex Members were able to meet through virtual platforms and progress work.

- 2.3 Fiji and Vanuatu, as the new and previous Coordinator of CCNASWP, and EWG chairs, met with Members from the region virtually to further develop the regional workplan as commissioned by CCNASWP15.
- 2.4 A regional workplan with activities to be implemented in the CCNASWP region in 2020-2021 to support the implementation of the SP was submitted to the CCEXEC subcommittee and presented in a document from the CCEXEC subcommittee to CCEXEC81 (November 2021) together with workplans from other regions.<sup>3</sup> The same document also included reports from the regional Coordinators on the major achievements and challenges in implementing the workplan in their regions and the next steps they envisaged.

# 3. Major achievements in the NASWP region during 2020-2022

- 3.1 Fiji has made significant progress in its role as regional Coordinator despite the challenges caused by the pandemic times including by
  - i. Completing the CCNASWP Regional Workplan development through an EWG.
  - ii. the successful assignment of a Codex Contact Point (CCP) through the office of the Chief Economist of the Ministry of Agriculture of Fiji to support their role of Regional Coordinator and establishment of a generic email address for communication.
  - iii. updating of the contact list for each Member
  - iv. strengthening of the NCC and increased participation of its members in various Codex meetings and activities, including the observance of World Food Safety Day which was organized through the Regional Coordinator office.
  - v. Contributing to implementing the Regional Communications Workplan
- 3.2 Codex Members in the NASWP region continued to actively participate in and contribute to Codex work at the global level, using the possibilities the virtual platforms provided to the maximum extent. As such, the region has significantly contributed to the implementation of the SP at the global level,
- 3.3. Although the COVID-19 pandemic caused delays in the implementation of the regional work, considerable progress was made. Major achievements are outlined in Annex I.

#### 4. Next steps for the region

- 4.1 Due to the challenges posed by the COVID-19 pandemic in progressing the implementation of the workplan, it is proposed that the workplan for 2021-2022 is maintained for the next two years and that some specific activities are carried out as indicated in Annex I.
- 4.2 A progress report on the Codex Communication Workplan (Annex II) summarizes the activities in terms of communication in the past two years and put forward suggestions on future plan.

#### **CODEX COMMUNICATIONS WORKPLAN - PROGRESS REPORT**

(Prepared by the Codex Secretariat)

### 1. INTRODUCTION

1.1 The FAO/WHO Coordinating Committee for North America and the South West Pacific at its fifteenth Sessio n (CCNASWP15) acknowledged the importance of prioritizing regional Codex communications and adopted the Regional Communications Workplan 2020-2025<sup>4</sup> with the objectives of establishing clear communication channels and communicating the value of Codex Standards in the region.

1.2 Both traditional and social media offer opportunities for raising awareness of Codex issues whether at the highest political level or when reporting, for example, on technical and capacity building initiatives. The Communications Workplan had two key objectives; i) to establish clear communication channels e.g. through the creation of rapid communications groups and ii) to communicate the value of Codex standards in the region. The Communications Workplan also aimed to contribute to the implementation of the Codex Strategic Plan 2020-2025, namely Strategic Goal 3 "Increase impact through the recognition and use of Codex standards"; in particular Objective 3.1 "Raise the awareness of Codex standards". This paper highlights the progress made on implementation of the Regional Communications Workplan and proposes that the region maintain such a work plan moving forward.

#### 2. SUMMARY OF PROGRESS

#### Objective 1: Establish clear, communication channels

- 2.1 The Coordinator has worked to continue communication among Members in the region by means of email.
- 2.2 It is also important that Members ensure that the official contact detail of their CCP<sup>5</sup> are up to date as this ensures that they receive formal communications from the Codex Secretariat. Updates can be provided directly to Codex@fao.org.
- 2.3 CCNASWP15 set a target that by CCNASWP16, 75 percent of Members/Observers surveyed would indicate timeliness, accessibility and quality of Codex regional communications "excellent" or "good". To facilitate receipt of information on this, a very short survey has been developed. Members are encouraged to complete this survey at: <a href="https://forms.office.com/e/ubtx5q2uub">https://forms.office.com/e/ubtx5q2uub</a> which will only take 2-3 minutes and the results will be provided during the discussion on Agenda Item 6.

#### Objective 2: Communicate the value of Codex standards in the region

- 2.4 The proposed activities under this objective primarily related to sharing information related to success stories in the region, stories on food safety, standards work or capacity development initiatives in the region and activities undertaken under Codex Trust Fund (CTF) projects. There has been an effort in the region to document and communicate activities through the preparation of short web stories that have been subsequently published on the CCNASWP news page<sup>6</sup> on the Codex website.
- 2.5 Over the past three years World Food Safety Day has provided the main incentive to raise awareness on food safety and share information on national and regional initiatives. Six countries in the region have contributed stories since CCNASWP15<sup>7</sup>. While not quite reaching its target of 50 percent of countries contributing to news items, this represents an improvement.
- 2.6 Published news on the Codex website provides valuable information about key achievements from Members on food safety issues, beyond awareness raising and training and presents a low resource opportunity to communicate on activities in the region. In particular, it could be valuable for the small island developing states to share their experience, successes, ongoing challenges and future needs. The Codex Secretariat remains available to provide support and guidance in this area and can share the approach of other regional coordinators in making improvements in this area through ongoing encouragement of members to share information on their activities and progress, however small.
- 2.7 There are currently two CTF recipient countries in the region, Samoa and Tonga. Sharing information on activities and initiatives implemented under the CTF is a valuable means of sharing experiences and lessons learned and highlighting progress. This is an area which could be further exploited in terms of communications moving forward.

#### 3. CONCLUSION AND RECOMMENDATION

3.1 The regional communication channels are currently based around email exchanges, and this is an area that has scope for expansion. With regard to Objective 2, World Food Safety Day served as an important driver, and this can be further exploited. The CTF can also provide an opportunity for improving communications. Moving forward, efforts should be made to continue to build communications into all initiatives to maintain this situation, as well as to engage other Members in the region to share their experiences.

- 3.2 In this context, it is recommended that CCNASWP16:
  - renew its commitment to the Communications Workplan, as updated in Annex II;
  - continue its efforts to enhance the regional communications network; and
  - enhance efforts to communicate on and promote its food safety and standard setting efforts and successes.
