BACKGROUND

1. The present Circular Letter aims to collect information on developments since the 17th Session of the Committee at the national level in the countries of the Codex Latin America and the Caribbean region to facilitate discussion of issues relating to national food control systems, consumer participation in food standards setting and the involvement in Codex work and use of Codex standards at the national level. A questionnaire is attached to the present Circular Letter to continue gathering information on the status of food control systems development, current priorities and capacity development/training needs.

- 3. Codex Members and Observers are invite to submit the information in a clear and concise way in order to facilitate the translation of comments and their consideration by the Committee. In particular for updating of national legislation cross-references to addresses where the information can be obtained (e.g. websites) rather than detailing such information in the paper is preferred.

Item 5 - National food control systems, national structures for Codex matters and consumer participation in food standards setting

Question 1: Strengthening National Food Control Systems
