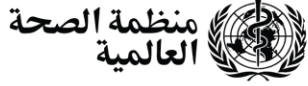

**(c) Aims and subject fields (mandate) of organization, and methods of operation. (Enclose charter, constitution, by-laws, rules of procedures, etc.). Date of establishment**

The Association is a non-profit making organisation whose main purpose is to represent, promote and project the interests of plant bakers in Europe and beyond as appropriate. The Association represent the member interests at the institutions of the European Union and other international institutions and organisations. AIBI aisbl examines and monitors existing and proposed legislation and regulations and provides scientific, technical and consumer oriented information about bakery products. As well AIBI aisbl promotes and enhances the positive image of bread to consumers and to the media.

The Association was incorporated under Belgian law on 27/10/2011 and was granted moral person personality through Royal Decree dated 04/03/2012. All official information and publications are available through the Belgian companies and associations online databank at:

AIBI is a federation whose members are the national associations of industrial bakers in Europe. It also includes corporate members in countries where no such association exists. There are currently 16 associations from 15 countries and 3 corporate members. This brings together a total of approx. 500 companies of varying sizes (from 15 to several thousand employees) involved in all forms of bakery production. Details of these companies can be found on the websites of the member associations. To our knowledge, none of our member organisations enjoy observer status with the Codex Alimentarius Commission.



**(e) Structure (assembly or conference; council or other form of governing body; type of general secretariat; commissions on special topics, if any; etc.).**

The Highest decision-making body is the General Assembly of Members. The Association is led by a Board of Directors. Day-to-day management is assured by a Presidium and the Secretary General. The Association has a permanent Technical Committee and organise ad hoc task forces when required to address specific topics.

**(f) Indication of source of funding (e.g. membership contributions, direct funding, external contributions, or grants).**

The funding of the Association is based on membership fees that are paid by the Member Associations and corporate members. The Association currently receive no external grant.

**(g) Meetings (indicate frequency and average attendance; send report of previous meeting, including any resolutions passed) that are concerned with matters covering all or part of the Commission's field of activity.**

The General Assembly meets yearly, the Board 3 times / year likewise the Technical Ctee. Additional ad hoc meetings are organised as needed. No resolution of specific relevance to the Commission's field of activity has been passed yet, but the Technical Ctee regularly monitors and works on contaminants of relevance to the ingredients acquired by the bakers for manufacturing their products.

**(h) Relations with other international organizations: - UN and its organs (indicate consultative status or other relationship, if any). - Other international organizations (document substantive activities).**

AIBI has no existing relationship with international organisations. We are interested in developing relationship with FAO, but have so far not found any specific topic/activity that could support this intention. It is to be indicated that AIBI has relationships with the Industrial bakers organisations from other regions of the world (US, South America, Canada, South Africa, Taiwan, China, Japan, India).

**(i) Expected contribution to the Joint FAO/WHO Food Standards Programme.**

As a main staple food in many regions of the world, we anticipated that our observer status could contribute to the work of the Commission.

We believe that we could contribute to further develop and foster food safety practices throughout the entire food system and support the advocating for the adoption and deployment of Codex standards. Concretely, as a first example, we have noted the ongoing work of the Contaminants Committee on the revision of the Code of Practice for the Reduction of Acrylamide in Foods (CXC 67-2009) and believe that we could contribute to this important work. We are of course willing to bring our expertise in other topic of relevance.

**(j) Past activities on behalf of, or in relation to, the Codex Alimentarius Commission and the Joint FAO/WHO Food Standards Programme (indicate any relationship by national affiliates with the Regional Coordinating Committees and/or the National Codex Contact Points or Committees for at least the last three years preceding the application).**

None to report so far.

We would like to be able to answer to the request for information (CL 2024/79-CF), through the OCS, and possibly if appropriate, join the electronic working group that is busy with this topic.

WFA is an international animal protection network aiming to achieve global impact for animals by providing a platform for the animal protection movement on the international stage. The WFA rests on a broad base of support from over 73 member global animal protection organisations from around the world in all geographical regions who joined forces and work together towards a broad representation of the interests of animals in international policy fora.

By harnessing the collective strength of the animal protection movement, we tap into a momentous opportunity to ensure that animals are, at last, considered within global policymaking.

We do this through:

- Researching, collaboratively developing policy and advocacy strategies and sharing policy analysis and information to better the understanding of the UN system, its processes and implications at the national level as a basis for effective advocacy
- Coordinating and elevating NGOs' global advocacy efforts to maximize the impact of our work through cross-fertilization and strategic advocacy across policy silos.
- Advocating on behalf of the animal protection movement with one professional, clear, and unified position on key animal issues.

WFA works through policy working groups on global public health issues, some of which are within the discussion scope topics of the commission.

One of the major ones is the **Food Systems working group** which develops joint strategies and narratives for WFA members to advocate for animal protection in key intergovernmental processes related to food systems.

WFA also represents civil society organizations in the Quadripartite Antimicrobial Resistance Multi Stakeholder partnership platform (MSPP) led steering committee hosted by FAO and chairs an action group on the nexus between **Antimicrobial Resistance and Animal welfare**. We lead narrative development on leveraging animal welfare to promote healthier animals, reduce disease emergence and incidence, and decrease antimicrobial use, addressing the root causes of AMR to achieve sustainable public health

These working groups are composed of experts from around the world, within our member organizations but also with research institutions. When called upon by the commission, these experts can be appointed by WFA as a representative on the commission's subject matters of Food safety and quality and Antimicrobial Resistance discussion to provide views in writing without abridgement to:

- sessions of the Commission
- sessions of specified subsidiary bodies, meetings
- seminars on subjects organized under the Joint FAO/WHO Food Standards
- programme which falls within its fields of interest,
- provide written statements on matters before the Commission
- to participate in discussions when invited by the Chairperson.

WFA's members work on a range of activities related to the Codex Alimentarius, through a focus on the production, trade and consumption of animals and animal products, as well as innovation and promotion of alternative plant-based proteins.



**Annex II****Principles concerning the participation of international non-governmental organizations in the work of the Codex Alimentarius Commission**

(...)

**Procedure for obtaining observer status****International non-governmental organizations having status with FAO and/or official relations with WHO**

18. Observer status shall be accorded to those INGOs in consultative status, specialized consultative status or liaison status with FAO or INGOs having official relations with WHO that inform the Secretary of the CAC of their desire to participate in the work of the Commission and/or any or all of the Commission's subsidiary bodies on a regular basis. They may also request invitations to participate in specific sessions of the Commission or its subsidiary bodies on an ad hoc basis.

**International non-governmental organizations neither having status with FAO nor official relations with WHO**

19. Before any form of formal relationship is established with a non-governmental organization, such organization shall supply the Secretary of the Commission with the information outlined in the Annex to these procedures.

20. The Secretary of the Commission will verify the completeness of the information provided by the organization and will also perform an initial assessment of whether the organization appears to meet the requirements indicated in paragraph 16 of these principles. In case of doubt, he or she will consult with the Directors-General of FAO and WHO and may seek further information and clarifications from the organization as appropriate.

21. Upon satisfactory completion of the verification and assessment referred to in the previous paragraph, the Secretary of the Commission will submit the application and all relevant information received from the applicant to the Executive Committee for its advice, pursuant to Rule IX.6 of the Rules of Procedure of the CAC.

22. The Secretary of the Commission will transmit the application, together with all relevant information received from the applicant and the advice of the Executive Committee, to the Directors-General who will decide whether an organization is to be granted observer status. In case of rejection of an application, a re-application by the same organization shall not normally be considered until two years have elapsed since the Directors-General's decision on the original application.

23. The Secretary of the Commission shall inform each organization of the Directors-General's decision on its application and shall provide a written explanation of the decision in case of rejection.

**Relations between International Non-Governmental Organizations holding Observer Status with Codex (added)**

24. Observer status at specific meetings will not normally be granted to individual organizations that are members of a larger organization authorized and that intends to represent them at these meetings.
