WORK FROM THE CODEX COMMITTEE ON RESIDUES OF VETERINARY DRUGS IN FOODS
(CCRVDF) FOR ADOPTION OR APPROVAL BY THE COMMISSION

1. The Commission is invited to adopt the standards and related texts submitted for final adoption. The relevant texts from CCRVDF are listed in **Part 1** of this document.
2. Comments received regarding proposed draft standards and related texts from CCRVDF are contained in CX/CAC 23/46/7 Add.1.
3. The Commission is also invited to approve the Priority List of Veterinary Drugs as referenced in **Part 2** of this document.
4. The Commission is furthermore invited to endorse discontinuation of work proposed by CCRVDF as listed in **Part 3** of this document.
5. The critical review of these texts was undertaken by the 84th Session of the Executive Committee of the Codex Alimentarius Commission (CCEXEC84).
6. It is noted that CAC38 (2015)¹ had agreed to hold the draft MRL for rbSTs at Step 8 to allow further time to facilitate a possible consensus and that the draft MRLs would continue to be on the agenda of the CAC and open to discussion.
