# CODEX WORK RELEVANT TO THE REGION

(Prepared by the Coordinator for Europe)

#### I. BACKGROUND AND INTRODUCTION

1. Since the revitalization of the FAO/WHO Regional Coordinating Committees (RCCs) in 2016, the identification of Codex work relevant to the region has been a recurrent agenda item in all RCC sessions.

2. At the 32nd Session of the FAO/WHO Coordinating Committee for Europe (CCEURO32), Members highlighted the following issues related to Codex work that was ongoing at the time of the session:

- (i) operationalization of the Statements of Principle Concerning the Role of Science in the Codex Decision-Making Process and the Extent to which other Factors are Taken into Account (SoP);
- (ii) participation in consultations aimed at finding a consensus on proposed maximum residue limits (MRLs) for zilpaterol hydrochloride;
- (iii) implementation of Codex texts on antimicrobial resistance (AMR);
- (iv) webcasting Codex meetings, including sessions of the Executive Committee of the Codex Alimentarius Commission (CCEXEC);
- (v) the need for a more balanced allocation of work between Codex subsidiary bodies, including through the Codex Committee on General Principles (CCGP); and
- (vi) strengthening the One Health approach within Codex activities.

# II. PURPOSE

3. In line with the terms of reference for RCCs, which stipulate that the Committee shall draw the attention of the Codex Alimentarius Commission (CAC) to any aspects of CAC's work of particular significance to the region, this document aims to facilitate the identification of relevant ongoing Codex work, issues related to these work items, and possible ways of addressing them.

#### III. WORK ITEMS OF RELEVANCE TO THE REGION

4. The information presented is based on feedback provided by Members from the region to the Coordinator for Europe, data on participation in Electronic Working Groups (EWGs), and comments by Members from the region in the CAC and its subsidiary body sessions.

#### A. MATTERS OF RELEVANCE DISCUSSED AT THE CODEX ALIMENTARIUS COMMISSION, ITS EXECUTIVE COMMITTEE, AND THE CODEX COMMITTEE ON GENERAL PRINCIPLES

Operationalization of the SoP

5. CAC46 (2023) agreed on the need to gain more experience on the application of the draft guidance, and to revisit the draft guidance in the light of the experience gained.<sup>1</sup>

Members from the European region are encouraged to share any experience gained in the use of the draft guidance.

Consultations on finding a consensus for the draft MRLs for zilpaterol hydrochloride in cattle liver, kidney and muscle

6. During July and August 2023, the CAC Chairperson and Vice-Chairpersons held informal consultations with 89 Codex Members to facilitate consensus on the draft MRLs for zilpaterol hydrochloride in cattle liver, kidney and muscle. The views of 30 Member countries from the European region (59%) were shared during these consultations. CAC46 (2023) adopted the MRLs for zilpaterol hydrochloride in cattle liver, kidney and muscle at Step 8 by vote.<sup>2</sup>

# Antimicrobial resistance (AMR)

7. At CCEXEC84 (2023), the Codex Secretariat informed that the revised *Code of Practice to Minimize and Contain Foodborne AMR* (CXC 61-2005) would be part of the survey on use and impact of Codex standards in 2024.<sup>3</sup>

Members from the European region are encouraged to take into consideration the existing Codex texts on foodborne AMR when defining and implementing their national strategies to address AMR and to use the 2024 survey to share information on their endeavours.

#### Webcasting

8. CAC46 (2023) noted the interest of CCEURO in webcasting sessions of CCEXEC and requested the Codex Secretariat to further explore this issue considering the existing practices in other similar FAO bodies, and to present a paper at CAC47 (2024).<sup>4</sup>

Members from the European region are encouraged to share their experience with webcast meetings since CCEURO32 and to actively engage in the discussion on this subject at CAC47.

#### One Health approach

9. CAC46 (2023) encouraged FAO and WHO to continue their fruitful collaboration when implementing the FAO Food Safety Priorities and WHO Global Strategy for Food Safety, including through the food safety element of the Quadripartite One Health Joint Plan of Action.<sup>5</sup>

10. In discussions at CAC45 (2022)<sup>6</sup>, e.g. in relation to MRLs for pesticide residues, Members from the European region stressed the need for Codex to reflect on how to ensure that the close links between human, animal and environmental health were identified and addressed in Codex work, in particular given that the statutes of CAC stipulate coordination of all food standards work.

Members from the European region are encouraged to identify possible ways of addressing the One Health approach in the frame of Codex work.

#### New work and work prioritization

11. CCEXEC85 (2023)<sup>7</sup> recommended that the Codex Secretariat work to prepare practical guidance and engage with Members to address the challenges related to new work and work prioritization, as recommended by CCEXEC83 (2022).

Members from the European region are encouraged to identify challenges related to new work and work prioritization as well as potential solutions to facilitate the preparation of practical guidance by the Codex Secretariat.

#### Virtual sessions of CAC and subsidiary bodies

12. At CCGP33 (2023), the Codex Secretariat confirmed that the Codex Rules of Procedure would continue to be interpreted in a manner that includes virtual sessions of CAC Subsidiary Bodies. With respect to sessions of CAC, CCGP33 deferred the review of the Rules of Procedure and requested FAO and WHO to inform CCGP34 on their possible plans to amend their rules of procedure to include virtual meetings of their Governing Bodies. CCGP33 further emphasized the importance of flexibility in working modalities for Codex meetings.<sup>8</sup>

Members from the European region are invited to take note of the outcome of CCGP33 and encouraged to share lessons learnt on the use of the new working modalities employed by CAC and its subsidiary bodies with the Coordinator for Europe to inform future discussions on the "model for future Codex work" (CX/EXEC 23/85/3, Appendix II) - a living document which CCEXEC85 (2023) agreed to periodically review.

### Standard for Fruit Juices and Nectars

13. CAC46 (2023) agreed to establish an EWG under CAC to consider the proposal to amend the *General Standard for Fruit Juices and Nectars* (CXS 247-2005) regarding the Brix levels for *Vitis labrusca* and hybrids thereof and to submit a report to the Codex Secretariat for consideration by CCEXEC87 and CAC47 (2024).<sup>9</sup>

Members from the European region that registered experts to the EWG under CAC are encouraged to submit comments on the proposed amendments in preparation of the consideration of the issue by CCEXEC87 and CAC47.

# B. MATTERS OF RELEVANCE DISCUSSED IN TECHNICAL COMMITTEES

14. The following non-exhaustive list of ongoing Codex work of potential relevance to CCEURO is based on feedback provided by Members to the Coordinator for Europe, participation in EWGs, and comments made by Members in informal coordination meetings organized by the Coordinator for Europe for sessions of CAC subsidiary bodies since 2023.

# IV. RECOMMENDATIONS

15. CCEURO33 is invited to discuss the issues raised in paragraphs 5-13 and Table 1 and make recommendations for consideration by the Commission.
