## REQUEST FOR COMMENTS

2. Codex members and observers are invited to provide comments on the MLs for lead in certain food categories as presented in CX/CF 24/17/5, Appendix I, while taking into account the information provided under the key points of discussion (paragraphs 15-28) and the data/information presented/assessed in Appendices II and III of the said document.
3. Appendix I is uploaded to the Codex Online Commenting System (OCS): <https://ocs.codexalimentarius.org/>. Comments provided through the OCS should follow the guidance provided in paragraphs 5-9.
4. Codex members and observers are encouraged to submit comments in reply to this CL<sup>2</sup> in order to facilitate the consideration of the MLs and its finalization at the upcoming CCCF.

## GUIDANCE ON THE PROVISION OF COMMENTS

5. Comments should be submitted through the Codex Contact Points of Codex members and observers using the OCS.
6. Contact Points of Codex members and observers may login to the OCS and access the document open for comments by selecting "Enter" in the "My reviews" page, available after login to the system.
7. Contact Points of Codex members and observers' organizations are requested to provide proposed changes and relevant comments/justifications on a specific paragraph (under the categories: editorial, substantive, technical and translation) and/or at the document level (general comments or summary comments). Additional guidance on the OCS comment categories and types can be found in the OCS Frequently Asked Questions (FAQs)<sup>3</sup>.
