

## **REQUEST FOR COMMENTS**

- 2. Codex members and observers are invited to submit comments on:
- (i) the proposed draft revision to the GSLPF in Appendix II of CX/FL 23/47/5
- (ii) the proposed draft guidelines for the use of PAL in Appendix III of CX/FL 23/47/5, including:
  - a. the proposed location as an annex to the GSLPF (i.e. whether the guidelines should be incorporated as an annex to the GSLPF to ensure consistency with the GSLPF); and
  - the need to seek advice on standardised analytical methods and sampling from CCMAS (i.e. whether there is agreement to seek advice on appropriate methods for undertaking risk assessments, taking into account information provided within FAO/WHO scientific advice reports)
- (iii) whether to provide any advice to CCFH to ensure consistency with the Code of Practice on Allergen Management for Food Business Operators (CXC 80-2020).
- 3. When providing comments on the abovementioned, members and observers should review the summary of discussion, analysis and conclusions presented in Appendix I of CX/FL 23/47/5.
