Revision of the Classification of Food and Feed:

Class B – Primary food commodities of animal origin (all types) and Class E - processed foods of animal origin (all types)

Nigeria would like to thank the United States of America and the Netherlands for leading the work of the Electronic Working Group (EWG) on the revision of the classification of food and feed: Class B: Primary food commodities of animal origin and class E – Processed foods of animal origin (At Step 4).

Nigeria supports the document as revised: Class B: Primary food commodities of animal origin (Appendix I) and Class E: Processed foods of animal origin (Appendix II).

RATIONALE: The document is comprehensive and has a wider coverage of Food of Animal Origin.

Revision of the classification of food and feed: portion of the commodity to which maximum residue limits apply, and which is analyzed for group 006 assorted tropical and sub-tropical fruits - inedible peel and group 023 oilseeds

- i. Nigeria appreciates United States of America, and the Netherlands for leading the work of the Electronic Working Group (EWG) on the revision of the classification of food and feed: Portion of the commodity to which maximum residue limits apply, and which is analyzed for particularly Group 006 Assorted Tropical and Sub-Tropical Fruits – (Inedible Peel). Nigeria however request that the word "Inedible peel" should be defined.
- Nigeria supports the position expressed by Ecuador on the analysis of MRL on the portion of commodities to include the whole fruit with peel for Group 006 Assorted Tropical and for Sub-tropical fruits inedible peel (avocado, passion fruit, banana, pineapple, kiwi, mango, papaya).
- iii. Nigeria proposes that the portion of the commodity to which MRL applies (and which is analysed) on Group 023 Oilseeds to include the whole seeds or kernels.

RATIONALE: What is 'inedible' in one country may be edible in other countries.
