Agenda Item 1. **Adoption of the Agenda** (Doc. Ref. CX/NFSDU 08/30/1). In accordance with Rule VII.2 of the Rules of Procedure, the first item on the Provisional Agenda shall be the adoption of the Agenda.

Agenda Item 2. Matters Referred to the Committee by the Codex Alimentarius Commission and/or Other Codex Committees Including Matters Arising from FAO and WHO (Doc. Ref. CX/NFSDU 08/30/2). The document will include matters referred to it by the Codex Alimentarius Commission and/or other Committees and also information from FAO and WHO which is relevant to the work for the Committee. The document is based on the information prepared by the Codex Secretariat.

Agenda Item 3. Guidelines for the Use of Nutrition Claims: Draft Table of Conditions for Nutrient Contents (Part B Containing Provisions on Dietary Fibre) at Step 7 (Doc. Ref. CL 2007/43-NFSDU and ALINORM 08/31/26, Appendix II) Following the decision of the 29th session of the CCNFSDU, the above Circular Letter was issued asking comments and additional input on the definition of dietary fibre. Comments at Step 6 are incorporated in document CX/NFSDU 08/30/3.

Agenda Item 4. Draft Advisory List of Nutrient Compounds for Use in Foods for Special Dietary Uses Intended for Infants and Young Children: Part D Advisory List of Food Additives for Special Nutrient Forms: Provisions on Gum Arabic (Gum acacia) at Step 7 (Doc. Ref. CL 2007/43-NFSDU; ALINORM 08/31/26, Appendix V). The 29th Session of the CCNFSDU returned the provision on gum arabic for further comments and consideration by the 30th Session of the Committee.

Agenda Item 5. Draft Nutritional Risk Analysis Principles and Guidelines for Application to the Work of the Committee on Nutrition and Foods for Special Dietary Uses at Step 7 (Doc. Ref. ALINORM 08/31/26, Appendix VI). The 29th session of the CCNFSDU advanced the above document to the Commission for adoption at Step 5. The Committee is invited to consider the document section by section and agree on proposed amendments. Comments at Step 6 would be compiled in CX/NFSDU 08/30/5.

Agenda Item 6. Proposed Draft Recommendations on the Scientific Basis of Health Claims at Step 4 (Doc. Ref. CX/NFSDU 08/30/6). The 29th session of the CCNFSDU agreed to return the above document for redrafting by the elctronic working group led by France and further consideration by the 30th session. Document CX/NFSDU 08/30/6-Add.1. would contain comments at Step 3 issued for the 30th Session of the CCNFSDU.

Agenda Item 7. Proposed Draft Additional or Revised Nutrient Reference Values for Labelling Purposes in the Codex Guidelines on Nutrition Labelling at Step 4 (Doc. Ref. CX/NFSDU 08/30/7). The Committee at its 29th Session had agreed to request the 31st Session of the Commission to approve new work on the revision of Nutrient Reference Values of Vitamins and Minerals for Food Labeling Purposes and agreed that the Delegation of Republic of Korea with assistance of other interested parties would prepare a revised document for consideration by the 30th Session of the Committee. Comments at Step 3 would be issued as CX/NFSDU 08/30/7-Add.1.

Agenda Item 8. Discussion Paper on the Proposal for New Work to Amend the Codex General Principles for the Addition of Essential Nutrients to Foods (CAC/GL 09-1987) (Doc. Ref. CX/NFSDU 08/30/8). The 29th Session of the CCNFSDU had requested the Delegation of Canada to prepare a revised document, narrowing its scope in the light of the comments provided at the current session. The revised document would be considered by the 30th Session of the Committee.

Agenda Item 9. Discussion Paper on the Proposal for New Work to Establish a Standard for Processed Cereal-Based Foods for Underweight Infant and Young Children (Doc. Ref. 08/30/9). At its 29th Session the Committee had agreed that the Delegation of India with assistance from other interested parties would revise the document and prepare a more structured project document for consideration by the 30th Session of the Committee.

Agenda Item 10. Other Business and Future Work. In accordance with Rule VII.5 of the Rules of Procedure, any Member of the Commission may propose the inclusion of specific items in the Agenda with respect to matters of an urgent nature. The Committee may propose to undertake new work which shall be in compliance with the Codex Alimentarius Commission's Strategic Plan 2008-2013, subject to approval by the Codex Alimentarius Commission or its Executive Committee.

Agenda Item 11. Date and Place of the Next Session. The Committee will be advised of the tentative place and dates of the next meeting.

Agenda Item 12. Adoption of the Report. In accordance with Rule X of the Rules of Procedure, the Committee shall adopt the report of its 30th Session based on a draft provided by the Secretariat.
