WORK OF THE CODEX COMMITTEE ON FOOD ADDITIVES (CCFA)

1. The 49th Session of the Codex Alimentarius Commission (CAC49) is invited to adopt the standards and related texts submitted for adoption by CCFA56 as listed in **Part 1** of this document.
2. The comments received regarding standards and related texts submitted for adoption by CAC49 are contained in CX/CAC 26/49/8 Add.1.
3. CAC49 is also invited to revoke existing specific provisions in the *General standard for food additives* (GSFA, CXS 192-1995) as recommended by CCFA56 and referenced in **Part 2** of this document.
4. CAC49 is furthermore invited to discontinue work on specified draft food additive provisions as recommended by CCFA56 and referenced in **Part 3** of this document.
5. The critical review of these standards and related texts will be conducted by the 90th session of the Executive Committee of the Codex Alimentarius Commission (CX/EXEC 26/90/3 Add.2).¹
