Mapping of CFS scope and products in relation to SDG targets



The purpose of this document is to give an idea of the scope of CFS work and its potential contributions to efforts in advancing Agenda 2030 and the extent to which targets are inter-related. Grey text includes CFS products which have not yet been endorsed, the scope of which can at this point in time reasonably be expected to address or touch upon the corresponding targets.
