



Planning Notes

The CFS 46 Draft Provisional Agenda has been put together taking into consideration plenary decisions and feedback received from stakeholders on CFS 45 and previous CFS Plenary Sessions.

The Secretariat is waiting for an indication from FAO on the arrangements for World Food Day 2019 which falls on Wednesday 16 October so it has not been possible to draft the timetable yet. With that the Draft Provisional Agenda below is not in any particular order timewise. However, the proposed length of time to be allocated for each item is included and will fit into the week. An item to mark the International Day of Rural Women can be scheduled for 15 October.

As requested, the outcomes of each session, and what will be forwarded to the Drafting Committee for consideration, is indicated.

Items marked in yellow are pending a decision by the Bureau.

Proposed theme for CFS Week

On the 24 and 25 September 2019 there will be a High Level Political Forum (HLPF) SDG Summit under the auspices of the General Assembly which will assess progress so far on the Agenda 2030 and provide leadership and guidance on the way forward that could help accelerate implementation. CFS will send its contribution to the Summit, highlighting that by the current trends, the world is far from being on track to eradicate hunger and malnutrition and meet SDG2 targets by 2030. CFS 46 will be the first major global meeting following the SDG Summit and can build on its momentum.

Accordingly the agenda has been designed with the SDGs and the Agenda 2030 as its main theme. The State of Food Security and Nutrition Report uses the SDGs as indicators; there is a lesson sharing session to reflect on how CFS has been contributing to the SDGs, as well as ways to accelerate progress on them; and the MYPoW session will be forward looking on how CFS will continue to contribute to the implementation of the Agenda 2030.

Posting delegate statements online and including the speaker's list in the Final Report

It is recognized that CFS delegates need to make statements as part of their attendance to the CFS Plenary session. In order to give them more visibility the Secretariat could also post statements (in original languages) on the Session Web page either in advance or after delivery. Likewise, the speakers list of those who take the floor on each item could be included in the Final Report.
