



CFS HIGH-LEVEL SPECIAL EVENT ON STRENGTHENING GLOBAL GOVERNANCE OF FOOD SECURITY AND NUTRITION

13-15 October, 2020 | 1.00pm - 4.00pm (Rome Time)



OVERVIEW

This CFS *High-Level Special Event* will seek to keep food security and nutrition front and center on the global sustainable development agenda. During its three plenary sessions (one per day), the discussions will:

1. Take stock of the global food security situation guided by the **State of Food Security and Nutrition in the World (SOFI) 2020 report** and the **CFS High-Level Panel of Experts (HLPE) report on Building a Global Narrative towards 2030**;
2. Reflect on the impacts of COVID-19 on global food security and nutrition and efforts needed to “build back better” using the HLPE issues paper on **Impacts of COVID-19 on Food Security and Nutrition: Developing Effective Policy Responses to Address the Hunger and Malnutrition Pandemic**; and
3. Discuss the **draft CFS Voluntary Guidelines on Food Systems and Nutrition** and the **draft CFS Policy Recommendations on Agroecological and Other Innovative Approaches**, and consider their relevance to the objectives of the UN Food Systems Summit.

Based on CFS’s inclusiveness principle, the three-day Special Event will bring together representatives from Governments, United Nations agencies, civil society and non-governmental organizations, private sector associations, philanthropic foundations, international agricultural research centers, and international and regional financial institutions.

To enrich and complement the plenary discussions and to give our partners and stakeholders an opportunity to highlight their work, CFS will provide space for 12 virtual “Partners Events” over the three days – with 4 events per day. These partners events (two from 11.00am to 12.30pm and two from 4.30pm to 6.00pm), will be hosted/co-hosted and organized by selected CFS stakeholders. Each virtual side event will be allocated one and a half hours.

Overview of the Global Food Security and Nutrition Situation

“Exploring implications and recommendations of the SOFI 2020 Report and the CFS HLPE Report on Building a Global Narrative towards 2030”

Both the SOFI 2020 Report and the CFS High Level Panel of Experts (HLPE) report on *Building a Global Narrative towards 2030* recognize the need to transform food systems to achieve the SDGs. According to the SOFI report, almost 690 million people were hungry in 2019. An additional 130 million people could become hungry in the near future as a result of the COVID-19 pandemic. The 2030 Agenda for Sustainable Development calls for “bold and transformative steps which are urgently needed to shift the world on to a sustainable and resilient path.” In summary, “with 10 years to go until 2030, the world is off-track to achieve the SDGs targets for hunger and malnutrition” (SOFI 2020). It is critical for us to better understand how to reverse these trends in order to achieve SDG2.

- a. Review the current global situation of food insecurity and malnutrition;
- b. Discuss assumptions, data, costs, and pathways for accelerating action to achieve sustainable food systems during the 2020-2030 *Decade of Action*: and
- c. Consider how current players in the global food and nutrition governance architecture could most effectively work with CFS to deliver on SDG2.

COVID-19 and its Impacts on Global Food Security and Nutrition

"What can stakeholders do to respond, rebuild, and strengthen resilience of food SYSTEMS ahead of future zoonotic crises?"

The COVID-19 pandemic has challenged the world to tackle an unprecedented health crisis, highlighting the nexus between public health, food security and employment, and labor dimensions. The COVID-19 pandemic is clearly threatening the functioning of key food supply chains, which is a complex interaction involving farmers, agricultural inputs, processing plants, shipping, retailers, consumers and more. This is highlighting the risks, fragilities and inequalities characterizing food systems. This has shown the urgent need to rebuild resilient food systems that integrate sustainability in all three of its dimensions.
