# Bureau and Advisory Group Meeting Outcomes - With Bureau Decision

The CFS Chairperson, Ambassador Nosipho Nausca-Jean Jezile, welcomed the CFS Bureau and (ad hoc) Advisory Group Members and outlined the provisional agenda, which was subsequently adopted.

The Chairperson also took the opportunity to introduce and warmly welcome, with a round of applause, a new member of the CFS Secretariat: Mr. Kennedy Kariuki, originally from Kenya, who will support the team as a Digital Communication Intern.

Participants were informed that, in line with usual practice, the meeting would be recorded for the Secretariat's note-taking purposes.



#### 1. CFS 53 Draft Decisions and Conclusions:

#### a) SOFI

The CFS Chairperson introduced the Draft Conclusions on CFS 53 Item 2, noting that the only substantive section currently available and presented for consideration at this meeting were the outcomes of the CFS High-Level Forum on Tackling Climate Change, Biodiversity Loss, and Land Degradation through the Right to Food (Sub-item e)), while the following sub-items are still pending:

- Sub-item (b) awaiting the release of the SOFI report (scheduled for 28 July) and its key messages;
- Sub-item (d) waiting for the outcome of the second Collaborative Governance meeting, which is scheduled to take place on 24 July, as well as the subsequent summary report covering the entire workstream, including the earlier session on financing;
- Sub-item (f) is awaiting the outcomes of the Satellite Sessions, which still require some preparatory work before their expected outputs can be drafted.

The Chair also introduced the proposed Friends of the Chair process which, through informal consultations, is expected to facilitate consensus on the draft conclusions of Agenda Item II b at the Plenary.

Preliminary comments included suggestions to incorporate more language from the CFS Chair's Summary of the High-Level Forum on Climate Change, Biodiversity Loss and Land degradation.


#### **Bureau decision**

Bureau Members agreed to the proposed Friends of the Chair process. Following suggestions from members of the Bureau and Advisory Group to incorporate more language from the Chair's Summary on Climate change, Biodiversity loss and Land degradation, the Chairperson concluded that a revised version would be presented at the next Bureau meeting on 12 September. The Draft Conclusions, as discussed on 23 July, are attached hereto (Annex 3).

## b) HLF on Financing

The CFS Chairperson introduced the draft conclusions of the High-Level Forum on Strengthening responsible investment and financing for food security and nutrition.

The Bureau and Advisory Group members discussed the Draft Conclusions for the High-Level Forum providing inputs on several paragraphs and additions. These inputs were recorded for consideration during the Bureau meeting.





#### **Bureau decision**

Bureau members discussed the Draft Conclusions including the suggestions and additions provided during the Bureau and Advisory Group meeting and proposed to further consider and adopt the Draft Conclusions at the next Bureau meeting on 12 September. It was further agreed that the Secretariat will prepare a text proposal to frame the challenge of financing food security and nutrition and its magnitude based on the contribution provided in the HLPE-FSN background note on Strengthening Responsible Investment and Financing for Food Security and Nutrition. The Draft Conclusions, as discussed on 23 July, are attached hereto (Annex 3).

## c) Urban/peri-urban food systems

The CFS Chairperson presented this agenda item highlighting that the background document contained Draft Decisions – as per standard practice - for endorsement by the Plenary of the CFS Policy Recommendations on Strengthening Urban and Peri-Urban food systems.

The CFS Chairperson also took the opportunity to thank the Rapporteur, Dr. Balaji (India), for his excellent leadership and commitment to this policy process.

The Draft Decisions were well received by Bureau and Advisory Group Members.

#### **Bureau decision**

The Bureau approved the Draft Decisions as they were originally presented. These Draft Decisions are attached hereto (Annex 3).

## d) Building resilient food systems

The CFS Chairperson presented the Draft Conclusions which make reference to the presentation of the HLPE-FSN report, recalling the relevant sections of the MYPoW with regards to the policy convergence process that will follow in the 2024-2025 intersessional period

The Draft Conclusions were well received by Bureau and Advisory Group Members.

#### **Bureau decision**

The Burau approved the Draft Conclusions as they were originally presented. These Draft Decisions are attached hereto (Annex 3).

## e) Impact of CFS policy products

The Draft Conclusions were well received by Bureau and Advisory Group members who provided a few text proposals concerning bullets 1.c and 1.d.

#### **Bureau decision**

The Bureau approved the Draft Conclusions for this session with a couple of amendments to bullet 1.c, compared to the original version. The Draft Conclusions from the Bureau meeting of 23 July are attached hereto (Annex 3).



## f) MYPoW

The CFS Chairperson's proposal to discuss the draft decisions related to the MYPoW under agenda item 2 of this meeting — which concerns the MYPoW Mid-Term Review document — was welcomed.

A summary of these draft decisions is provided under item 2.

## g) Global Thematic Event

The CFS Chairperson presented this agenda item as a key issue for the Plenary, underlining that this year marks the 10th anniversary of the Framework for Action for Food Security and Nutrition in Protracted Crises (CFS-FFA), and that the current global geopolitical situation further emphasizes the importance and urgency of implementing these principles to improve the food security and nutrition of populations affected by, or at risk of, protracted crises.

She also referred to the Monitoring Report—attached as an annex to the background document BurAG/2025/07/23/01g—which was prepared by the Secretariat based on contributions received through the Call for Inputs and the technical guidance of the Technical Task Team. She noted that, in line with past practice, this report will also be included in the CFS Plenary background documentation as an information document.

The draft conclusions were well received by Bureau and Advisory Group members, who provided a few text proposals concerning bullets 1.d and 1.e.

#### **Bureau decision**

The Bureau approved the draft conclusions with minor amendments to bullet 1.e, the deletion of paragraph 1.f, and the retention of a proposed additional sentence—placed in brackets—in bullet 1.d, relating to the reference to the outcomes of the second meeting of the Collaborative Governance initiative on protracted crises. The bracketed text will be revisited during the Bureau and Advisory Group meetings in September, once the outcomes of the aforementioned meeting are available.



#### h) Commitment for nutrition

The Draft Conclusions were well received by Bureau and Advisory Group members and no comments or alternative text proposals were presented.

#### **Bureau decision**

The Burau approved the Draft Conclusions as they were originally presented. The Draft Conclusions are attached hereto (Annex 3).





#### 2. CFS MYPoW Mid-Term Review

The CFS Chairperson expressed appreciation to the Rapporteur, Ms. Erma Rheindrayani of Indonesia, for skillfully guiding the process to a successful conclusion. She highlighted the inclusive approach that shaped the preparation of the MYPOW Mid-term Review document, which integrates diverse and valuable contributions from Members and Participants throughout the various drafting stages.

Ms. Rheindrayani then presented the few additional changes made to the document after the 16 June deadline for written comments, notably regarding the title and timing of the event on Strengthening the Impact of CFS Policy Products. The event is now scheduled for CFS 55 in 2027 instead of during the intersessional period, resulting in reduced interpretation costs. She also noted the inclusion of several new references: the contribution of forests and agroforestry in section A.2.3; the Global Hub on Indigenous Peoples' Food and Knowledge Systems in section A.2.4; civil society and the private sector in section B.1; and engagement in the Third Global Parliamentary Summit against Hunger and Malnutrition in section B.2.

Comments from Bureau and Advisory Group Members included:

- a) a suggestion to rename the event on Strengthening the Impact of CFS Policy Products from "Forum" to "Global Thematic Event";
- b) a proposal to amend Table 2 to better reflect the flexibility regarding the scheduling of the two High-Level Fora planned for 2026 and 2027;
- c) a recommendation to include a reference to human rights in section A.1.5;
- d) a suggestion to replace the term "land" with "tenure" in section A.1.6.


Following the discussion of the MYPOW Mid-term Review document, the Chairperson introduced the accompanying Draft Decision, which was well received by Bureau and Advisory Group Members.

#### **Bureau Decision**

The Bureau endorsed the aforementioned changes (a and b) in the MYPOW Mid-term Review Document, as well as the related Draft Decision as originally presented and attached hereto (Annex 3).

#### 3. Workstream updates

The CFS Chairperson presented the workstream updates, making reference to the background document prepared on this item and highlighting upcoming events in July, including the Collaborative Governance Dialogue on food security and nutrition in protracted crises and the UNFSS+4 Stocktake Moment in Addis Ababa.





#### **Bureau discussion**

The CFS Chairperson's introduction mirrored the morning's session with no further comments by Members.

## 4. HLPE-FSN: critical issues for food security and nutrition

The CFS Chairperson introduced this agenda item and the following key points discussed in relation to the item HLPE-FSN: critical issues for food security and nutrition:

The proposal to formalize the process through which the HLPE could alert the Bureau on critical issues that it deems deserving urgent attention from the Committee was welcomed.

During the discussion was highlighted the need for the HLPE to liaise with the RBAs when preparing a note identifying a critical issue.

It was also noted that there could be synergies with the Collaborative Governance workstream, as well as with the ongoing revision of the MYPOW.

#### **Bureau decision**

The proposal to formalize the process through which the HLPE could alert the Bureau on critical issues that it deems deserving urgent attention from the Committee was welcomed. It was also confirmed that comments made during the Bureau and Advisory Group (BAG) meeting are to be integrated in the finalization of the document.

The need to institutionalize the HLPE's contribution to the MYPOW review process was also noted.

#### **5.** CFS Umbrella Programme

Bureau and Advisory Group members were informed of the objectives, structure, content and functioning of the Umbrella Programme which is intended to facilitate the provision of extrabudgetary resources by reducing the time required for the formulation of bilateral projects and by implementing a more efficient reporting mechanism.

The importance of ensuring a clear connection between the Umbrella Programme and the CFS MYPoW was highlighted by different members as a key point.

It was clarified that visibility will be given to the Umbrella Programme in the CFS website and that informational materials will be prepared to raise awareness among CFS stakeholders and potential donor partners.



#### **Bureau discussion**


The Bureau agreed to dedicate an item at the upcoming Bureau and Advisory Group meeting in September for the CFS Secretariat to present an update on the financial status of the CFS and on the implementation of the Resource Mobilization Strategy as well as an overview of the different existing mechanisms through which resources can be provided to CFS.

## **6.** Any Other Business

#### **Bureau discussion**

During the Bureau meeting, several Members proposed exploring new ways to structure the agendas for both meetings, which currently span a full day (morning for the joint Bureau and Advisory Group meeting and the afternoon for the Bureau meeting). This suggestion arises from the observation that the agendas often overlap, resulting in repetitive discussions. Revising the format could help optimize time, improve the effectiveness of exchanges with the Advisory Group and enhance transparency in decision-making.

The CFS Chairperson welcomed the proposal and requested that the Secretariat develop a new structure and format based on this discussion. This should be submitted as a background document for discussion at the next joint Bureau and Advisory Group meeting in September, and for decision by the Bureau.





## HIGH LEVEL FORUM ON STRENGTHENING RESPONSIBLE INVESTMENT AND FINANCING FOR FOOD SECURITY AND NUTRITION

#### **DRAFT CONCLUSIONS**


- 1. The High Level Forum draws and reflects on the outcomes of events which took place prior to the CFS Plenary in 2025, such as the 4th UN Conference on Financing for Development in Sevilla, including its preparatory process, and the second Stocktake of the UN Food Systems Summit in Addis Ababa as well as the CFS Collaborative Governance Dialogue on financing for food security and nutrition and activities of relevant initiatives such as the Global Alliance Against Hunger and Poverty. The Forum is opened by the CFS Chair, followed by two panel discussions.
- 2. The first panel on what has been achieved in terms of <u>responsible</u> investment and financing for food security and nutrition in 2025, next steps and role of the CFS is composed of:

- 4. The Committee:
  - a. welcomes the High-Level Forum which brings together a wide range of stakeholders to discuss the challenges and opportunities related to mobilizing sufficient and adequate financial resources for food security and nutrition objectives and provide solutions, policies and promote collaboration for improved and increased <u>responsible</u> investments aimed at the progressive realization of the right to adequate food in the context of national food security;
  - b. takes note of the overview provided in document CFS 2025/53/Inf.20 "HLPE-FSN Background Note on Strengthening Responsible Investment and Financing for Food Security and Nutrition";
  - c. welcomes the presentations of the outcomes of the <u>CFS Collaborative Governance</u> <u>Dialogue on Financing for Food Security and Nutrition, held on 15 April, the</u> 4<sup>th</sup> UN Conference on Financing for Development held in Seville from 30 June to 3 July 2025, as well as of the second Stocktake of UN Food Systems Summit (UNFSS+4), which took place in Addis Ababa from 27 to 29 July, and highlighted the importance of following up on these outcomes to implement agreed actions;



- d. emphasizes the role of the public sector in financing food security and nutrition, including through repurposing of national expenditures, creating enabling environments to promote <u>responsible</u> investment and enhance access to finance as well as the need to align public financing policies with sustainable development objectives, including particularly policy objectives related to climate and the environment;
- e. encourages the private sector to <u>responsibly</u> invest in agrifood systems, particularly in developing countries, using a long-term, strategic approach, and emphasizes the need to develop an enabling policy environment which facilitates <u>responsible</u> private investment in agriculture and food systems, and the role that public investments can play in incentivizing and derisking <u>responsible</u> private investments;
- e.2. encourages financing that is effective, innovative, sustainable and consistent with national mandates and regulatory frameworks, particularly for developing countries to encourage investment in food systems and to support the progressive realization of the right to adequate food;
- f. underlines the critical importance of producers, particularly small-scale and family farmers and [the private sector in mobilizing resources for investment as well as]-their essential contributions through self-financing for food security and nutrition objectives and stresses the need to support them with domestic resources and conducive public policies that ensure fair prices for their products and access to credit at reasonable rates [in shaping conducive policy environments];
- g. highlights the role of Multilateral Development Banks in fostering collaboration between different stakeholders, promoting access to finance, developing innovative and effective financing mechanisms as well as in supporting public private partnerships while respecting the right to adequate food;
- h. encourages all stakeholders to use relevant CFS policy products, in particular the Principles for Responsible Investment in Agriculture and Food Systems and the Policy Recommendations on Investing in Smallholder Agriculture for Food Security, to support the creation of enabling environments for responsible investments in food security and nutrition and to promote access to and the mobilization of financial resources in line with the progressive realization of the right to adequate food;
- i. reiterates the need to assist developing countries in attaining long-term debt sustainability through coordinated policies aimed at fostering debt financing, debt relief, debt restructuring and sound debt management, as appropriate, as well as building on existing work, the review of the sovereign debt architecture, in order to end hunger and guarantee food security and nutrition;

CFS POLICY RECOMMENDATIONS ON STRENGTHENING URBAN AND PERI-URBAN FOOD SYSTEMS TO ACHIEVE FOOD SECURITY AND NUTRITION IN THE CONTEXT OF URBANIZATION AND RURAL TRANSFORMATION

#### **DRAFT DECISION**

1. The Committee considers document CFS 2025/53/5 "CFS Policy Recommendations on Strengthening Urban and Peri-urban Food Systems to Achieve Food Security and Nutrition in the context of Urbanization and Rural Transformation" (Policy Recommendations) as presented by Mr Jujjavarapu Balaji (India), Rapporteur of the policy convergence process.

- a. endorses document CFS 2025/53/5 "CFS Policy Recommendations on Strengthening Urban and Peri-urban Food Systems to Achieve Food Security and Nutrition in the context of Urbanization and Rural Transformation" as an action-oriented, inter-governmentally agreed, voluntary and non-binding, global policy framework in support of country-led efforts towards improving food security and nutrition policies and actions;
- b. expresses its deepest appreciation for the effective leadership of the Rapporteur, and commends the work of the HLPE-FSN to prepare the report on "Strengthening Urban and Peri-urban Food Systems to Achieve Food Security and Nutrition in the context of Urbanization and Rural Transformation";
- c. welcomes the keynote intervention by [..]
- d. calls on all CFS stakeholders to support and promote the dissemination, use, and application of the Policy Recommendations at all levels within their constituencies, and in collaboration with other relevant initiatives and platforms, in line with the recommendations indicated within the "Action Plan to Strengthen the Uptake of CFS Policy Products" (CFS 2024/52/5);
- e. encourages all stakeholders to share commitments and document lessons learned from using the Policy Recommendations, and to share progress and experiences with the Committee in order to assess their continued relevance, effectiveness and impact in line with the standard monitoring practice of the Committee which is based on the principles of participation, transparency and accountability;
- f. recommends that FAO, IFAD and WFP, in collaboration with other relevant international organizations, continue assisting Members in strengthening their capacity to apply the Policy Recommendations, addressing the growing interconnectedness of urban, peri-urban and rural areas as a foundation for developing food security and nutrition policies that reflect the complex realities of these interlinked communities;



- g. decides to transmit the Policy Recommendations to the Governing Bodies of FAO, IFAD and WFP for their further consideration regarding implementation and support to their utilization at country level, in line with country requests and pursuant to Rule XXXIII, paragraph 17, of the General Rules of the Organization and Rule X, paragraph 1, of the CFS Rules of Procedure and in accordance with paragraph 22 of the CFS Reform Document;
- h. decides to request the United Nations General Assembly (UNGA), through the ECOSOC, to encourage wide dissemination and implementation of the Policy Recommendations to all relevant UN Organizations and Agencies, consistent with Rule XXXIII, paragraph 15, of the General Rules of the Organization, Rule X, paragraph 4, of the CFS Rules of Procedure, and paragraph 21 of the CFS Reform Document;
- i. agrees to include the Policy Recommendations in the Global Strategic Framework for Food Security and Nutrition (CFS GSF).


#### **DRAFT CONCLUSIONS**





# CFS MYPOW 2024-2027 MID-TERM REVIEW DRAFT DECISION

- a. endorses document CFS 2025/53/9 "CFS MYPoW 2024-2027 Mid-Term Review with Draft Decision" as presented by Ms Erma Rheindrayani (Indonesia), Rapporteur for the MYPoW Mid-term-review process;
- b. notes that the full implementation of the Multi-Year Programme of Work (MYPoW) 2024-2027 will be contingent upon sufficient financial and human resources, taking into consideration a manageable workload, in accordance with document CFS 2018/45/3;
- c. strongly encourages the three RBAs to honor their verbal agreement to share equally the costs of the CFS Secretariat budget, through either cash or in-kind contributions, as a symbol of joint ownership and shared commitment to the Committee via effective RBAs collaboration;
- d. welcomes the updated CFS Communication Strategy (CFS 2025/53/Inf.25), which aims to enhance the Committee's profile as the main international and inclusive intergovernmental platform for food security and nutrition policies;
- e. welcomes the updated CFS Resource Mobilization Strategy (CFS 2025/53/Inf.26), which seeks to diversify and increase funding from a wider range of sources while promoting non-earmarked extra-voluntary contributions to safeguard the Committee's neutrality and independence;
- f. encourages all stakeholders to consider how they can contribute to both communications and resource mobilization efforts to ensure that the Committee's work remains robust, inclusive and responsive to global, regional and national needs;
- g. emphasizes the application of the RBAs' safeguards against potential conflicts of interest regarding CFS funding.

## FOSTERING MOMENTUM AND POLITICAL COMMITMENT FOR NUTRITION: ACCELERATING ACTION TOWARDS 2030 AND BEYOND

#### **DRAFT CONCLUSIONS**

Welcomes the presentation delivered by the joint FAO/WHO Secretariat on the United Nations Decade of Action on Nutrition (2016-2025), which has been extended to 2030, and the planned informal consultations aimed at gathering inputs from various stakeholders, building momentum, strengthening political commitment and advancing global actions to improve nutrition outcomes through 2030 and beyond;
- Expresses deep concern that, despite notable progress in strengthening nutrition policies and improving health and nutrition outcomes in many countries, nutrition challenges persist globally;
- c. Underlines the relevance of the country commitments for action that were made at the Nutrition for Growth Summit held in Paris (France) in 2025 resulting in over 400 commitments made, and close to 28 billion dollars committed to reach food and nutrition-related targets and looks forward to their full implementation;
- d. Reiterates the critical role of CFS in promoting policy coherence and preventing fragmentation across the wide range of international initiatives addressing hunger, food insecurity, and all forms of malnutrition, and calls relevant stakeholders to promote the use of the CFS Voluntary Guidelines on Food Systems and Nutrition to support countries to develop multi-sectoral national policies, laws, programmes and investment plans for healthy diets through sustainable food systems.
