Food security and nutrition: Global Context and Challenges

- Growing hunger and malnutrition despite global efforts
- Complex governance architecture for food security and nutrition (actors, platforms, initiatives)
- Interlinked shocks (pandemic, climate, conflict, access to financing)
- This trend should be reverted by strengthening resilient food systems, enhancing international cooperation and mobilizing resources to finance tangible solutions


What is the role and value of CFS?

- UN's foremost multi-stakeholder platform on food security and nutrition
- Builds evidence-based, consensus-driven policy guidance (HLPE-FSN)
- Participatory space to collectively shape voluntary global food policy recommendations and guidelines
- Value of institutional linkages with ECOSOC (Decision 2011/217)
- The RBAs (FAO, IFAD and WFP) support the CFS since its inception and the work is relevant for their mandate
- CFS activities guided by Multi-Year Programme of Work (MYPoW) 2024-2027

How the CFS is funded:

- CFS is supported by the three RBAs (675 K annual contribution each in kind and in cash).
- HLPE-FSN fully funded through extra-budgetary resources
- **Objective of the RMS:** Strengthening the financial sustainability of the Committee and establish a more predictable and diversified multiyear extra-budgetary funding for the CFS MYPoW activities.





Resource Mobilization Strategy: A Coordinated Approach

- **Identify:** gaps based on MYPoW activities and potential resource partners
- **Engage:** build trust relationships and find adequate financial mechanisms for engagement
- **Negotiate:** encourage support through non-earmarked contributions
- **Manage and Report:** ensure transparency and accountability
- **Communicate:** promote achievements and sustain momentum

Principles Guiding Resource Mobilization

- Preserve the **core strategic functions of the CFS** and the technical character of the CFS and HLPE-FSN Secretariats
- Support resource mobilization efforts (**CSIPM and HLPE-FSN**)
- Ensure efficiency and **effectiveness** in CFS activities
- **Collaboration** with members and stakeholders to identify priorities
- Promote communication and **stakeholder engagement**
- Contribute to the **UN mandate** and objectives
- Respect the **legal framework** and application of RBAs safeguards against any potential conflict of interest

Modalities: Extra-Budgetary Resources

- **Small extra-budgetary contributions** – support regular budget costs
- **Non-traditional donors:** Member and non-member countries, development agencies, development banks, IFIs, private sector and philanthropic foundations
- **Implement institutional mechanisms** to facilitate mobilization of resources – **Umbrella Programme** and **Multi-Donor trust fund**
- **Partnership with RBAs to support technical cooperation** assistance
- **Develop knowledge products and activities**

Expected Outcomes of the RMS

1. Preserving the **policy convergence process** as a unique asset and key contribution to coordinate and promote coherence of FSN policies
2. Create **ownership and raise awareness of the CFS policy products** – support and target uptake at regional, local and national levels
3. Harnessing the **convening power** and positioning the **strategic role of CFS as a global platform** for discussion of FSN and sharing of best practices
4. Support **the role of the HLPE-FSN** as the science-interface of the CFS
5. Strengthening the **CFS Ecosystem** contributing to the RM efforts to create an enabling environment for the **inclusive participation of member countries**, with emphasis in the **most vulnerable**, including also the well-functioning of the **CSIPM**

- Identification of workstreams that require additional voluntary contributions
- Monitoring on a regular basis at CFS Bureau and Advisory Group meetings to review progress
- Dynamic activity to align with any update in MYPOW and RM efforts
