## Unscheduled and cancelled sessions

- 1. In Resolution 21/67, adopted in November 1967, the Conference authorised the Director-General to convene sessions of FAO bodies and expert consultations other than those approved in the Programme of Work and Budget, provided that such sessions be reported to the next Council session. Subsequently, the Council agreed at its 102<sup>nd</sup> Session (November 1992) that information on unscheduled and cancelled sessions should, from then on, be provided in the Programme Implementation Reports. This *Annex* reports on unscheduled and cancelled sessions for the biennium from 1 January 2016 to 31 December 2017.
- 2. The starting point of reporting for the 2016-17 biennium is the *List of Scheduled Sessions* presented as *Web Annex VIII* of the PWB 2016-17. The following data summarises movements during the reporting period 2016-17, which included 103 unscheduled sessions and 13 cancellations.
- 3. Details of these sessions are provided in the following pages, which follow the format of previous reports. Meetings that have no intergovernmental character, such as consultations of the FAO Secretariat with stakeholders, as well as informal briefings of Permanent Representatives and non-FAO meetings held on FAO premises, are not included in this list.
