## Organizational Setting

Food and Nutrition Security Impact, Resilience, Sustainability and Transformation (FIRST) is a FAO and the European Unionpartnership programme with the purpose of providing a policy assistance mechanism for improved food security and nutrition and sustainable agriculture. FIRST is designed to strengthen the enabling environment for food security and nutrition and sustainable agriculture in a number of selected priority countries. FIRST will be embedded within the FAO's programme management and coordination structure. It will contribute directly to the food security, nutrition and sustainable agriculture (FNSSA) policy and governance related results envisioned under FAO Strategic Objectives 1 and 2.

The Policy Officer works under the direct supervision of FAO Representative and technical guidance of FIRST Senior Technical Advisor (ESA). The Policy Officer works in close collaboration with Chief Economist in Planning and Development Department, Project Coordinator - Sindh Agriculture Growth Project, and government counterparts at provincial and federal levels, the EU Delegation in Pakistan and other relevant stakeholders in the country.

### **Reporting Lines**

The Policy Officer reports to the FAO Representative and on technical issues to FIRST Senior Technical Adviser (ES).

### **Technical Focus**

Provide leadership, guidance and operational support for results-based policy assistance, capacity development and facilitate policy dialogue around food and nutrition security and sustainable agriculture. Strengthen the enabling environment for food security, nutrition and sustainable agriculture in Pakistan.

## **Key Results**

Development and implementation of coherent, integrated and effective policy assistance, capacity development and governance for achieving food and nutrition security, agriculture growth and sustainable agriculture in accordance with the vision of provincial government and FAO Strategic Framework and in response to policy assistance needs and demands at provincial level (Sindh Province only) and country level.

### **Key Functions**

- Prepares and refines the FIRST Operational Work Plan in collaboration with Government of Sindh counterparts, FAO
  Country Office, EU Delegation in Pakistan and other relevant stakeholders, and regularly reports on progress and
  implementation:
- Organizes and leads in-depth assessments of the policy and institutional frameworks, intervention mapping and
  information management for FNSSA in Pakistan. Analyses province and country specific requirements, human resource
  and organizational capacity gaps and identifies areas for improvements through the in-depth assessment;
- Provides Technical Assistance to the government of Sindh in review of the capacity on policy analysis and capacity building
  of relevant departments, and takes a lead in planning and formulating capacity development plans for the Government of
  Sindh for food security, nutrition and sustainable agriculture. Facilitates and advocates for an inclusive policy dialogue and
  supports the establishment of multi-sectoral food and nutrition coordination mechanisms and institutional structures such as
  SUN, IPC TWG etc. at the federal, provincial and regional level as well as developing strategic partnerships around FNSSA;
- Provides technical and policy advice and supports the Government of Sindh in development and implementation of their strategies and policies including the Zero Hunger Programme and the Scaling Up Nutrition (SUN) Movement, as well as other programmes in ways that will galvanize and maximize their impact on FNSSA;
- Supports and integrates FAO's initiatives: Information for nutrition food security and resilience for decision making (INFORMED), Land Governance, Integrated Food Security Phase Classification (IPC), Scaling up Nutrition (SUN), and EU funded nutrition-related interventions into the the FNSSA agenda;

- Supports the Government of Sindh in overseeing the development of related capacity building materials; and promote synergy among the existing agriculture and FSN information management system at the provincial and national levels;
- Provides assistance to the Government of Sindh in the FNSSA sector by 1) contributing to meetings, workshops and seminars related to FNSSA at the provincial and national level, 2) organizing and contributing to meetings and conferences around FNSSA to promote evidence-based policy dialogue and develop effective working relationships/consensus with international and national partners, and 3) participating in resource mobilization activities for policy implementation and capacity buildings within the country, and
- Provides assistance as requested from the Government of Sindh and approved by the FAO to contribute to deepening the FNSSA context in Sindh.

# **Minimum Requirements**

- Advanced university degree in agricultural, food security, development economics, sustainable agriculture or a related field;

- Working knowledge of English and limited knowledge of one of the other FAO languages (Arabic, Chinese, French, Russian or Spanish)
