



# **Concept Note**

Launch Event of the Global Project Supporting the Implementation of FAO One Country One Priority Product Initiative under the Framework of FAO-China South-South Cooperation Programme

#### 6 December 2023

# **Background**

FAO has developed the One Country One Priority Product (OCOP) initiative to build more sustainable food value chains of Special Agricultural Products (SAPs), increasing access to healthy diets, improving farmers' livelihoods and economic growth, while minimizing the use of chemical inputs and natural resources, reducing food loss and waste, as well as minimizing negative impacts on the environment.

The SAPs have unique qualities and special characteristics that are associated with economic value, geographical locations, farming practices and cultural heritages. Compared to staple food crops, SAPs have not yet fully benefited from agricultural and rural development programmes, and include all kinds of agricultural products, with the potential of being utilized and promoted in local, national, regional and global markets. Therefore, the OCOP helps countries leverage their unique potential by identifying relevant SAPs and ensuring improved access to stable markets, opportunities to improve farmers' livelihoods, and entry points for reaching their defined country priorities.

The OCOP was launched by the FAO Director-General in September 2021 and has been launched in all five FAO regions between March and July 2022. In November 2022, the first round of OCOP Country Projects were launched in Bangladesh, Egypt, Malawi, Trinidad and Tobago, and Uzbekistan to promote jackfruit, date palm, banana, cocoa, and sweet cherry, respectively. Since then, regional launch events and implementation workshops at country level were held to share knowledge and scale up best practices.

As of November 2023, 83 Members across all five FAO Regions have committed to promoting the sustainable development of 53 SAPs, and all of them have been recognized as potential OCOP project countries. To date, over USD 14 million from various resources have been mobilized to support the implementation of the OCOP initiative.

The government of the People's Republic of China has pledged USD 5 million – the largest single contribution to the OCOP initiative received to date – to focus on global capacity building and in-country demonstration activities through the South-South Cooperation. South-South Cooperation has been used by FAO for more than 20 years to support knowledge and technology transfer and mutual collaboration and sharing. With this new contribution, 15 countries from the tropics, drylands and mountainous zones have been identified to support. They are:

# **Objective of the Event**

The event will provide more information on the support being provided through the FAO-China South-South Cooperation Programme, including:

- i) Announce the additional OCOP project countries and their respective SAPs;
- ii) Share experiences and best practices from the first round of OCOP project countries;
- iii) Brief on the progress made through the OCOP initiative and the way forward; and
- iv) Call on FAO Members and relevant stakeholders to actively support and engage in the OCOP initiative.

#### **Proposed Format of the Event**

The event will be organized in hybrid modality on Wednesday, 6 December 2023 from 12.30 to 13.30 hours (CET), on the sidelines of the 174th Session of FAO Council to be held from 4 to 8 December. The event will be held in the Sheikh Zayed Centre at FAO headquarters, while connection details for virtual attendance are indicated in the meeting agenda (**Annex**).

Given the broad interest that has been expressed in the OCOP initiative, interpretation services will be provided in the six official languages of the UN.

# **Expected Participants**

The event will be attended by OCOP focal points at national, regional and global levels, and government officials and FAO Country Offices in 15 recipient countries, as well as partner agencies and entities (e.g., academia, donors, the private sector, beneficiary farmers).

## **Expected Results**

It is expected that the event will create a better understanding and a broader recognition of the South-South Cooperation Programme and the OCOP initiative worldwide, synergies between FAO flagship initiatives and programmes, and support the implementation of the FAO Strategic Framework 2022-31 and achievement of SDG targets and indicators, in line with national priorities.
