Description of work	<p>The Terms of Reference of the EWG are as follows:</p> <ul style="list-style-type: none">• consider the outstanding issues in square brackets, taking into account the discussions at CCFO29, and the comments submitted at Step 5/6 in reply to the Circular Letter (CL 2026/24 - CAC) that would be issued subject to the adoption of the proposed draft standard at Step 5 by CAC49;• elaborate proposed draft revisions to <i>Standard for Edible Fats and Oils Not Covered by Individual Standards</i> (CXS 19-1981) that would need to be applied consequential to the final adoption of the proposed draft standard for microbial omega-3 oils at a future session of CAC; and• prepare a report of the EWG for consideration by CCFO30 (March 2028), which should be submitted at least three months prior to the session.

CCFO29 agreed to keep open the possibility to convene a pre-session working group in advance of CCFO30 to further refine the draft standard.
