Description of work	<p>The EWG should:</p> <ul style="list-style-type: none">(i) implement the management procedure for unsupported compounds without health concerns for periodic review as described in the report of CCPR54 (REP23/PR54, Appendix XI);(ii) consider the unsupported compound identified under the priority list in the implementation of the management procedure (REP23/PR54, paragraphs 243, 245, 246);(iii) coordinate with the Chairs of the EWGs on priority lists and national registration database, respectively, on the identification of other possible unsupported compounds in accordance with the management procedure; and(iv) based on the above considerations to present the outcomes of the actions made for consideration by CCPR55.
Timetable for work	The discussion paper on the management of unsupported compounds should be submitted to the Codex Secretariat for distribution and consideration by CCPR55 by not later than 31 March 2023
