<b>Description of work</b>	The EWG should revise the discussion paper on pyrrolizidine alkaloids ( <a href="#">CX/CF 23/16/11</a> ) based on the comments received in response to circular letter <a href="#">CL 2023/40-CF</a> issued by the Codex Secretariat requesting comments on the recommendations in the paper.
<b>Timetable for work</b>	The working paper should be submitted to the Codex Secretariat for distribution for comments and consideration by CCCF17 (2024) by <b>not later than 31 January 2024</b>
