Title: Management of unsupported compounds without public health concern(s) scheduled for periodic review by JMPR

The EWG should:

- i. examine carbaryl (008); methyl bromide (052); disulfoton (074); flumethrin (195), which were unsupported compounds identified under Agenda item 9 (Establishment of Codex schedules and priority lists of pesticides for evaluation/re-evaluation by JMPR);
- ii. examine ethoxyquin (035) identified under Agenda item 6.1 (MRLs for pesticides in food and feed (at Steps 7 and 4));
- iii. review the Management of unsupported compounds without public health concern scheduled for periodic review approach (REP23/PR54, Appendix XII), with the aim of improving clarity on its implementation and scope, considering the discussions described in paragraphs 242 and 246 of REP25/PR56, with input from the JMPR and Codex Secretariats as necessary.

Based on the above considerations to present the outcomes of the actions made for consideration by CCPR57 (2026).

Timetable for work The report on unsupported compounds (key points of discussions and recommendations) should be submitted to the Codex Secretariat for distribution and consideration by CCPR56 within 3 months before the plenary Session
