	b. continues the development of the annex on sprouts describing interventions relevant to control STEC, taking into consideration the written comments that were submitted through the Online Commenting System (OCS) in response to the CL 2022/56-FH, and CRDs submitted at CCFH53, as well as the general section of the guidance as agreed at CCFH53 (<u>REP23/FH</u> para. 75)
