# Call No. 1/ GCP/MCD/002/EC/2019 for Expressions of Interest for Participation in Land Consolidation

Dear Sirs/Madams,

The European Union funded project "Mainstreaming of the National Land Consolidation Programme" (MAINLAND) implemented by the Food and Agriculture Organization of the United Nations (FAO) and the Ministry of Agriculture, Forestry and Water Economy (MAFWE), invites groups of landowners to participate in the public Call for Expressions of Interest for Participation in Land Consolidation activities.

Groups of landowners whose agricultural land is located in the same territory (one or several villages, or part of the village area/micro location, presenting parts of one or several neighbouring cadastral municipalities) are entitled to participate.

To express their interest to participate in the Call, landowners should submit filled and signed form of Expression of Interest.

## 1 GENERAL INFORMATION AND MAIN REQUIREMENTS

#### 1.1 Introduction

This document contains the instructions for interested landowners regarding the public Call for Expressions of Interest for Participation in Land Consolidation No. 1/ GCP/MCD/002/EC/2019.

#### 1.2 Publisher of the Call

## 1.3 Subject of the Call

The subject of the Call is to invite all interested landowners to express interest for participation in land consolidation.

Based on the collected Expressions of Interest and in accordance to the procedure presented below in the section 3, project areas with potential for land consolidation will be selected.

Selected project areas will be the subject to feasibility studies to assess their suitability for land consolidation. In case of positive recommendations of the feasibility studies, the project areas will be subject to further support in implementation of land consolidation activities. All costs related to land consolidation projects' implementation will be covered by the MAINLAND project or funded by the available national support programmes.

### 1.4 Who can submit an Expression of Interest for land consolidation project

Groups of interested landowners (whose agricultural land is located in the same territory of one village, or a micro location, presenting parts of one or several neighbouring rural cadastral municipalities) are entitled to submit an Expression of Interest. A landowner is a physical or legal entity that has an established ownership right over an agricultural land based on contract, court decision or decision of state institution.

#### 1.5 What is considered as area suitable for land consolidation

When deciding to express an interest, groups of interested landowners should consider the following factors characterising the area potential for land consolidation:

<sup>&</sup>lt;sup>1</sup> Agricultural land, as defined in the Law on Agricultural Land, refers to plow fields, arable land, orchards, vineyards, olive groves, other perennial crops, meadows, pastures, wetlands, reeds, fisheries, as well as other utilized or unutilized (not suitable for cultivation) land which with the use of agro-mechanicaland agro-meliorative and hydro-meliorative measures could be converted into land suitable for agricultural production.





- Agricultural land ownership Agricultural land in private ownership should be dominant, in comparison to the state land;
- Scale of fragmentation High number and irregular shape of parcels per landowner;
- *Terrain and soil features* The proposed land consolidation project area should have as less diversified terrain configuration as possible (for example area is flat) and more uniformed soil quality (for example the same cadastral class);
- Percentage of agricultural land registered in the Real Estate Cadastre Majority of land parcels in the proposed land consolidation project area are registered in the Real Estate Cadaster;
- *Perennial crops coverage* The proposed land consolidation project area should have as less parcels covered with perennial crops, as possible;
- Presence of immovable objects in the land consolidation project area (as indicated in the Real Estate Register and in accordance to the situation on the ground) The proposed land consolidation project area should have as less immovable objects, as possible;
- *Cultivated land* The proposed land consolidation project area should encompass as much cultivated land, as possible.

Based on the factors presented above, indicative selection criteria have been developed and are presented below, in the section 1.6.

## 1.6 Eligibility and indicative selection criteria

#### 1.6.1 Eligibility criteria

Namely, those Expressions of Interest, where there is less than 90% of land parcels registered in the Real Estate Cadastre (from the total area for which interest for land consolidation is expressed), will be eliminated. The respective information on the level of registration of land will be provided by MAFWE from the Agency for Real Estate Cadaster, for all Expressions of Interest.





## 1.6.2 Indicative selection criteria

The indicative selection criteria according to which the submitted Expressions of Interest will be ranked,

are presented in the following evaluation grid:

#### 2 PREPARATION AND SUBMISSION OF THE EXPRESSION OF INTEREST

## 2.1 Content of the Expression of Interest

The interested landowners are obliged to use and fill in the form prepared for this Call (Annex 1), also available in electronic version.

The number of landowners signing the Expression on Interest is not limited.

One landowner can sign one or several Expressions of Interest, in case his or her land is located in different areas.

#### 3 PROCEDURE FOR SELECTION OF PROJECT AREAS

## Step 1 Opening

The Expressions of Interest will be opened on 5 July 2019, at the premises of the MAINLAND project without any public presence.

## Step 2 Filling in Questionnaire

Upon receiving the Expressions of Interest of the groups of interested landowners, meetings with the landowners that expressed an interest will be organised.

The aim of these meetings is to further detail the information and clarify the bottom-up approach based land consolidation process.

Meetings with interested landowners will be organized per village, in order to collect additional data on the proposed area as provided in the Questionnaire (Annex 4).

The contact person/s will be invited to organise all the interested landowners who submitted Expressions of Interest to participate on the scheduled meetings. Wider participation is going to be encouraged, as on these meetings other interested landowners who initially did not sign the Expression of Interest, may join. During the local meetings, the Questionnaire will be filled in by the MAINLAND project and the MAFWE representatives from the Department of Land Consolidation, Exchange and Identification of Parcels.

Data collected during the meetings will be further verified against administrative registers.

## Step 3 Data verification

In order to secure objectivity and transparency of the evaluation process against the indicative selection criteria, correctness of the information presented in the Questionnaires filled in during the local community meetings and in the Expressions of Interest will be verified by MAFWE and the MAINLAND project, using the official available data sources.

## **Step 4 Ranking**

The Selection Committee, comprised of MAINLAND team and MAFWE, chaired by the FAO Chief Technical Advisor is responsible for the final selection of the land consolidation project areas. The selection will be performed based on ranking the Expressions of Interest in accordance with the indicative selection criteria presented in section 1.6.

The best ranked 12 Expressions of Interest that are scored with the highest points will be selected for initiation of land consolidation projects.

## **Step 5 Notification about the selection results**

All interested landowners who submitted the Expressions of Interest will be officially informed in writing about their scoring and the results of the selection.

Notification letters will be sent to the contact persons of each local community indicated in the submitted Expressions of Interest.
